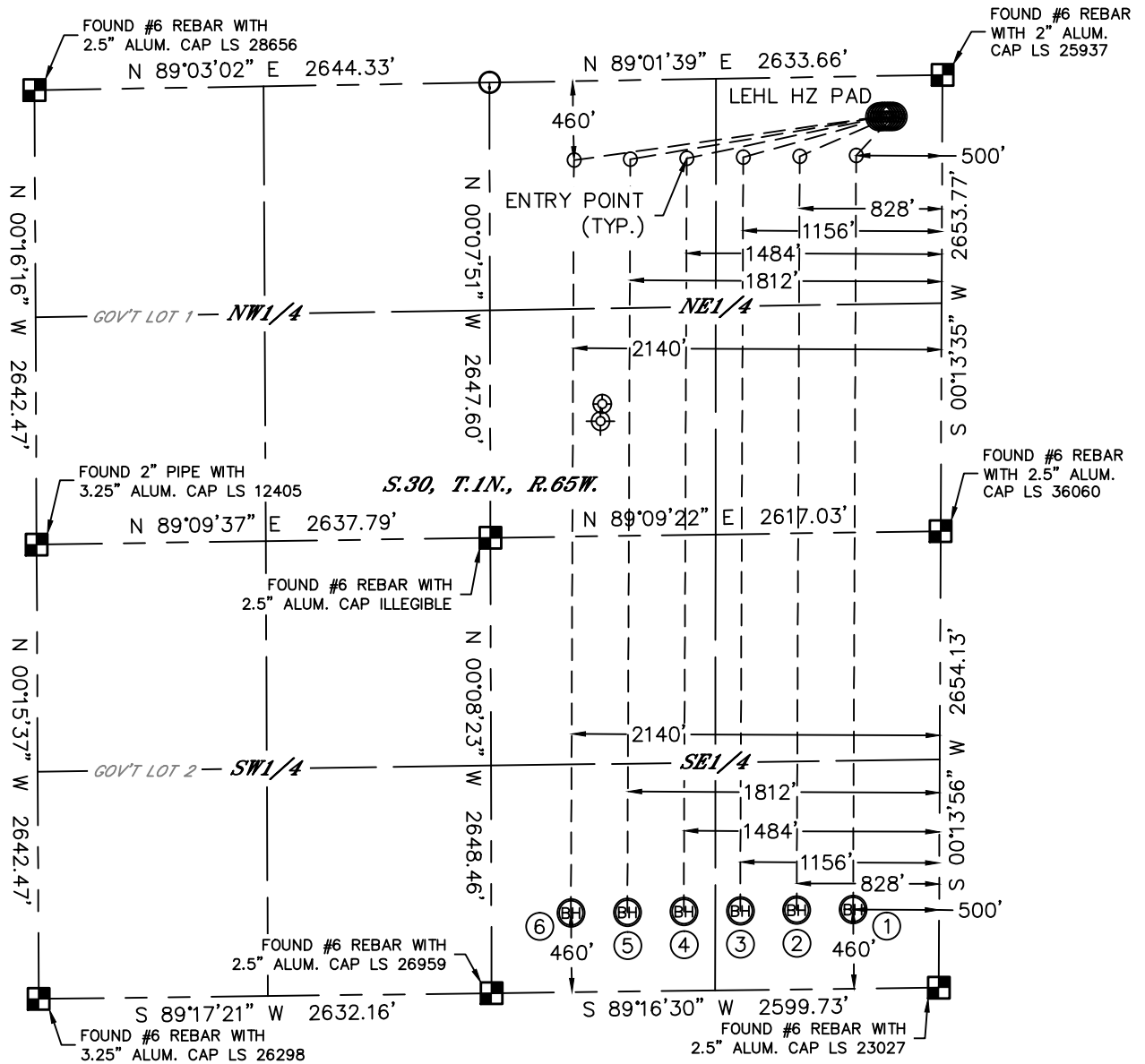

# MULTI-WELL PLAN

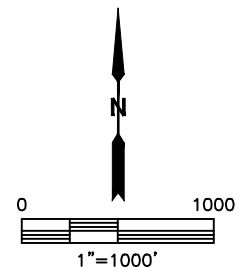
