COMMENTS:

This form is being submitted for notification of final pit closure completion at the Federal 2-10-84, Remediation Project #6774. The production pit at the 2-10-84 was being closed at the request of the Colorado Oil and Gas Conservation Commission(COGCC). National Fuel Corporation(NFC) submitted soil samples to Confluence Energy for testing with their product named "Ecosponge". After a 28 day test was conducted with the Ecosponge product, the soil samples were found to be within the range of acceptable levels for contaminants listed in the COGCC 910 series rules. Subsequently, NFC submitted a land farm plan to remediate the impacted soil. The plan that was approved by the BLM and COGCC, was implemented on August 7th, 2013. The first post-treatment sampling was conducted in October 2013. The results of this sampling showed all contaminates to be within the acceptable range of the COGCC Table 910.1.

Based on these results, NFC has proceeded with the following:

1. Removed soil from land farm area, and placed back in excavated pit area.
2. Berm material around land farm has been spread over area where remediated soil was removed.
3. Land farm and pit area will be roughed and seeded this fall between October 1st and December 1st, 2014, with mixture in COA of original APD.
