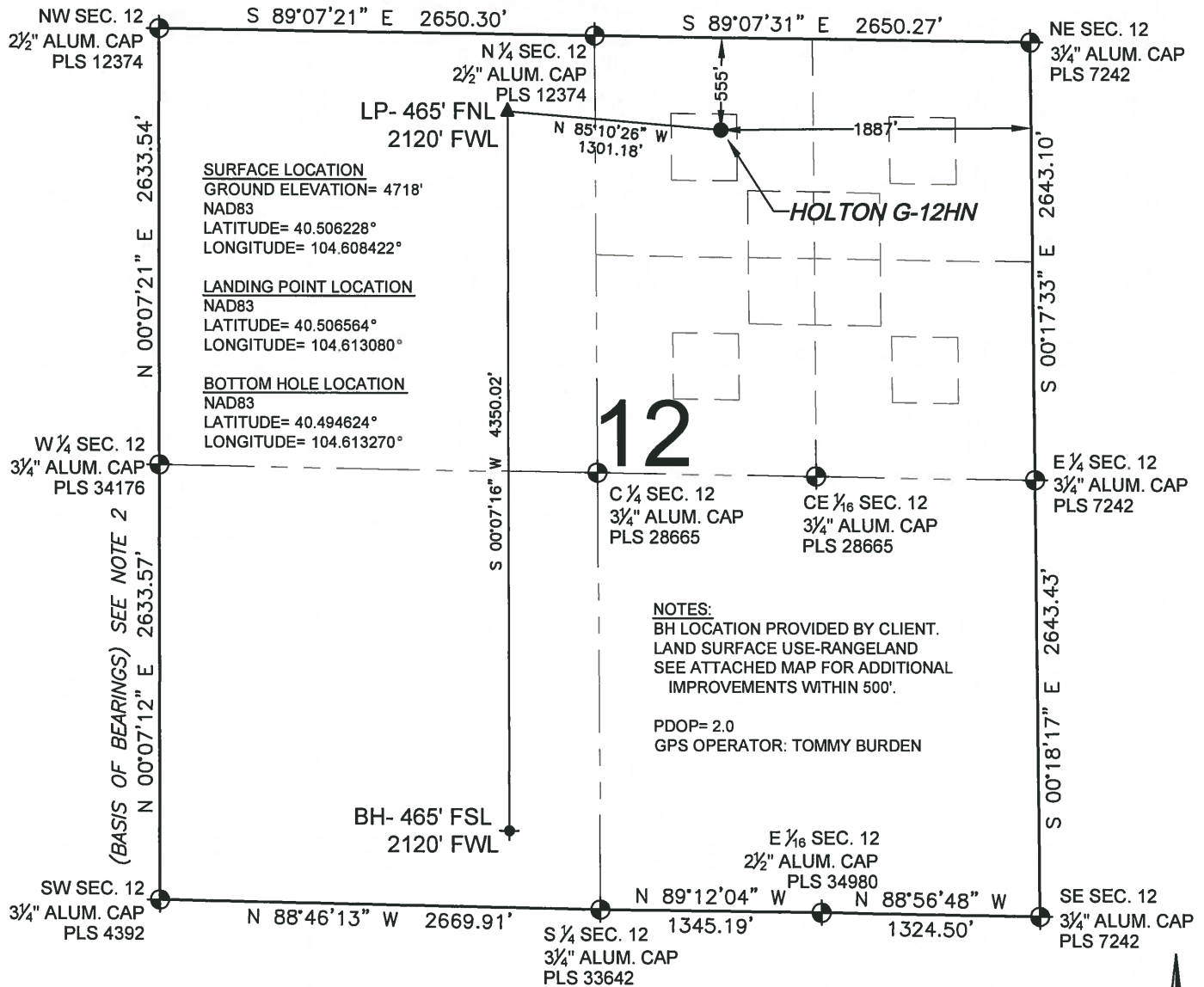
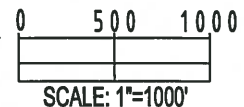


WELL LOCATION CERTIFICATE: HOLTON G-12HN
