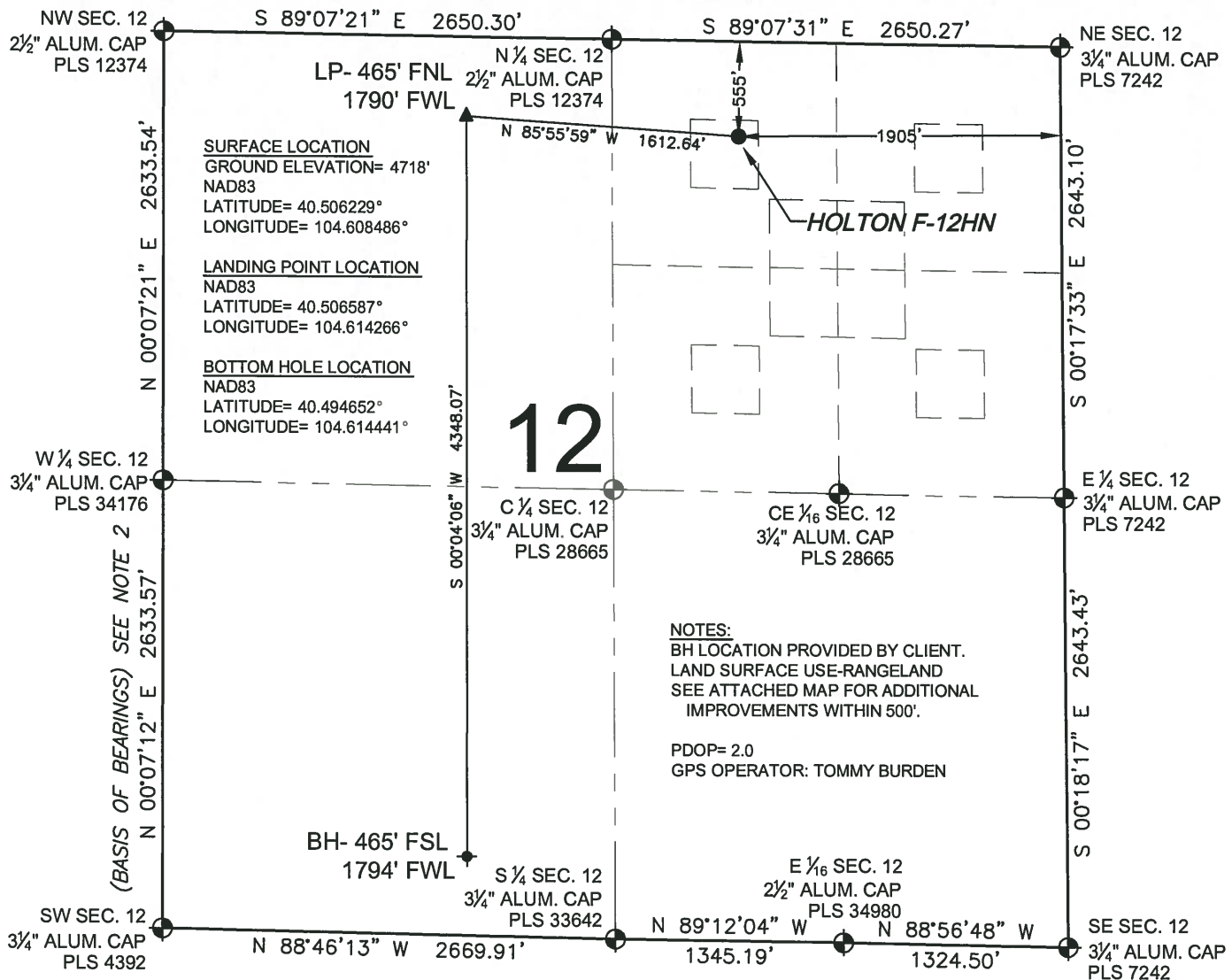
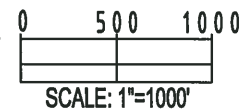


# WELL LOCATION CERTIFICATE: HOLTON F-12HN

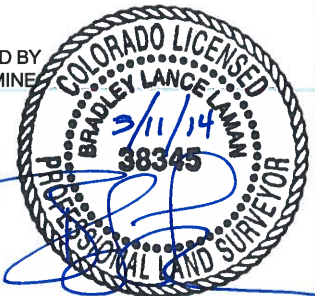
- = EXISTING MONUMENT    ▲ = LANDING POINT
