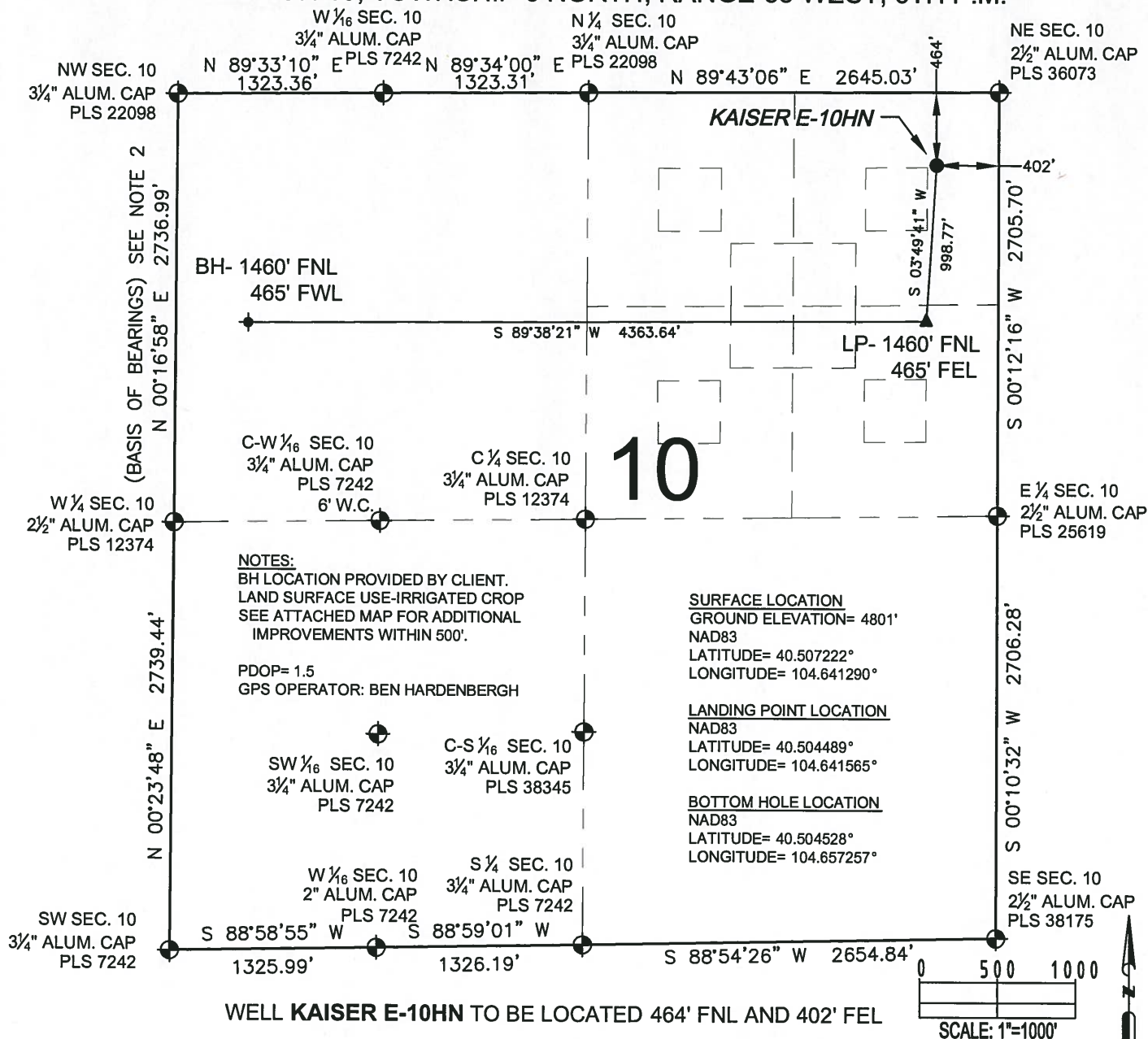


# WELL LOCATION CERTIFICATE: KAISER E-10HN

## LEGEND

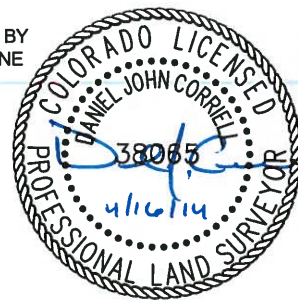
- = EXISTING MONUMENT
