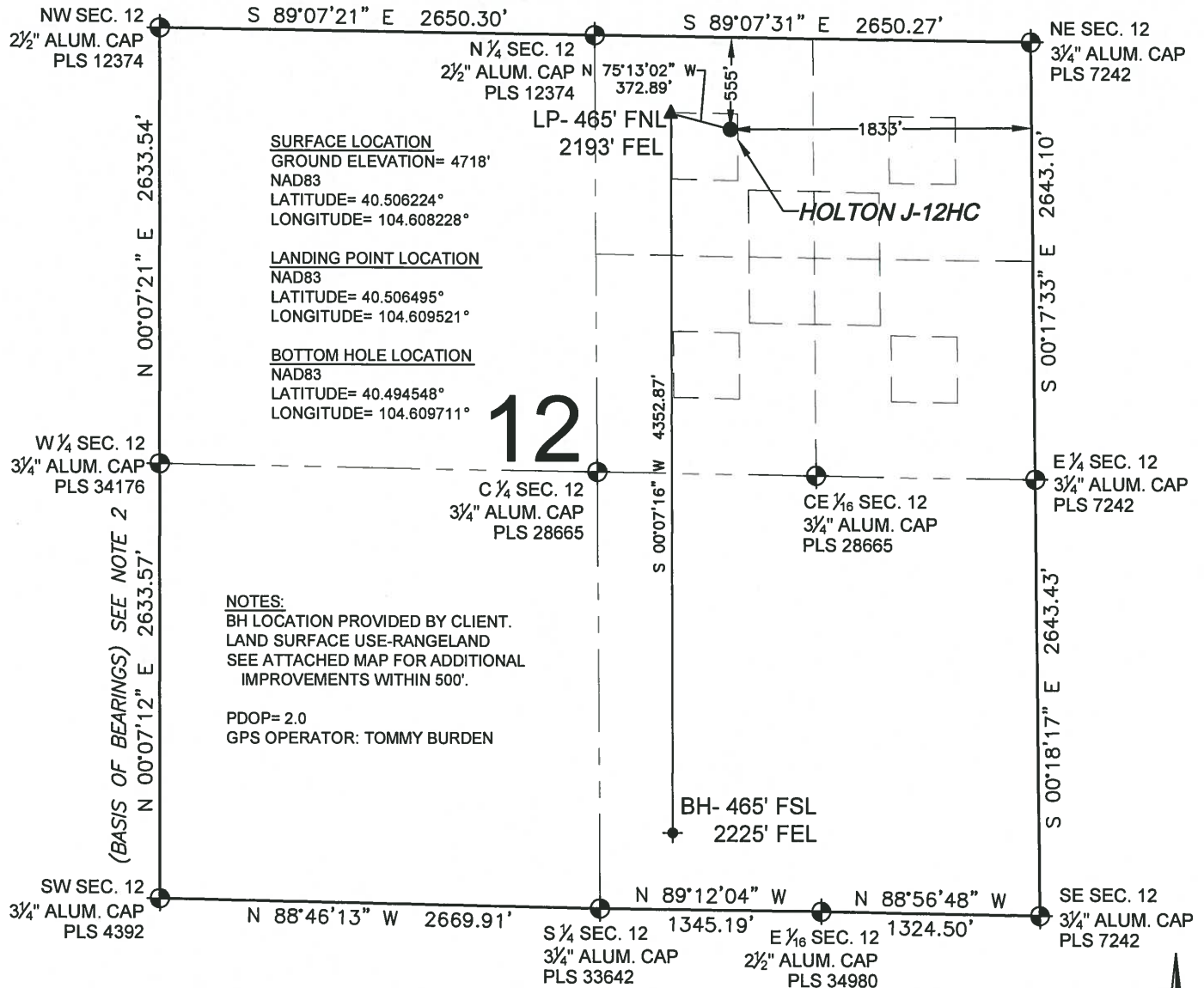


WELL LOCATION CERTIFICATE: HOLTON J-12HC
