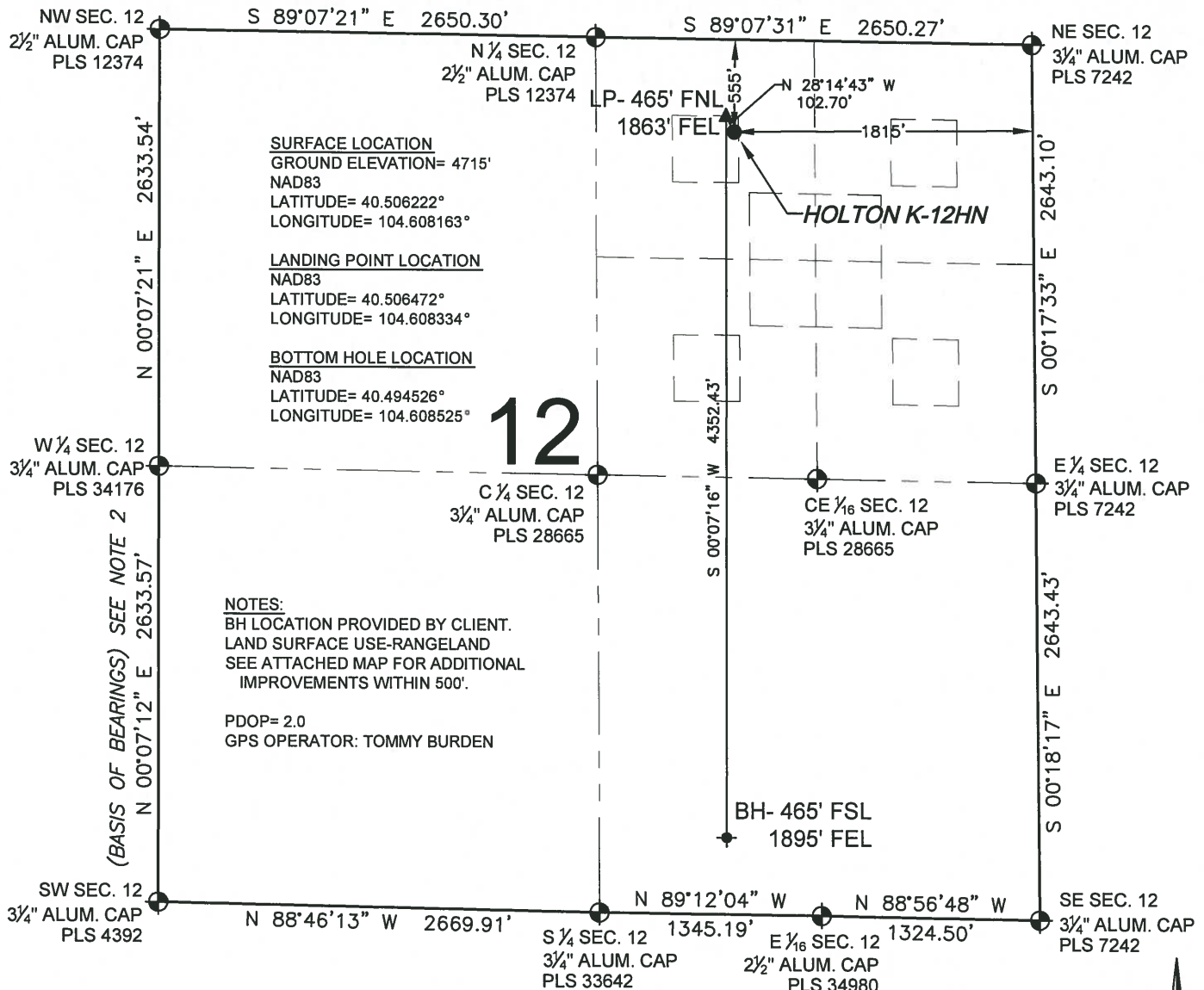
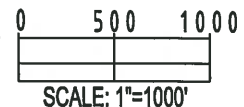


WELL LOCATION CERTIFICATE: HOLTON K-12HN

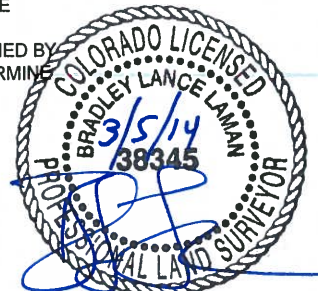
