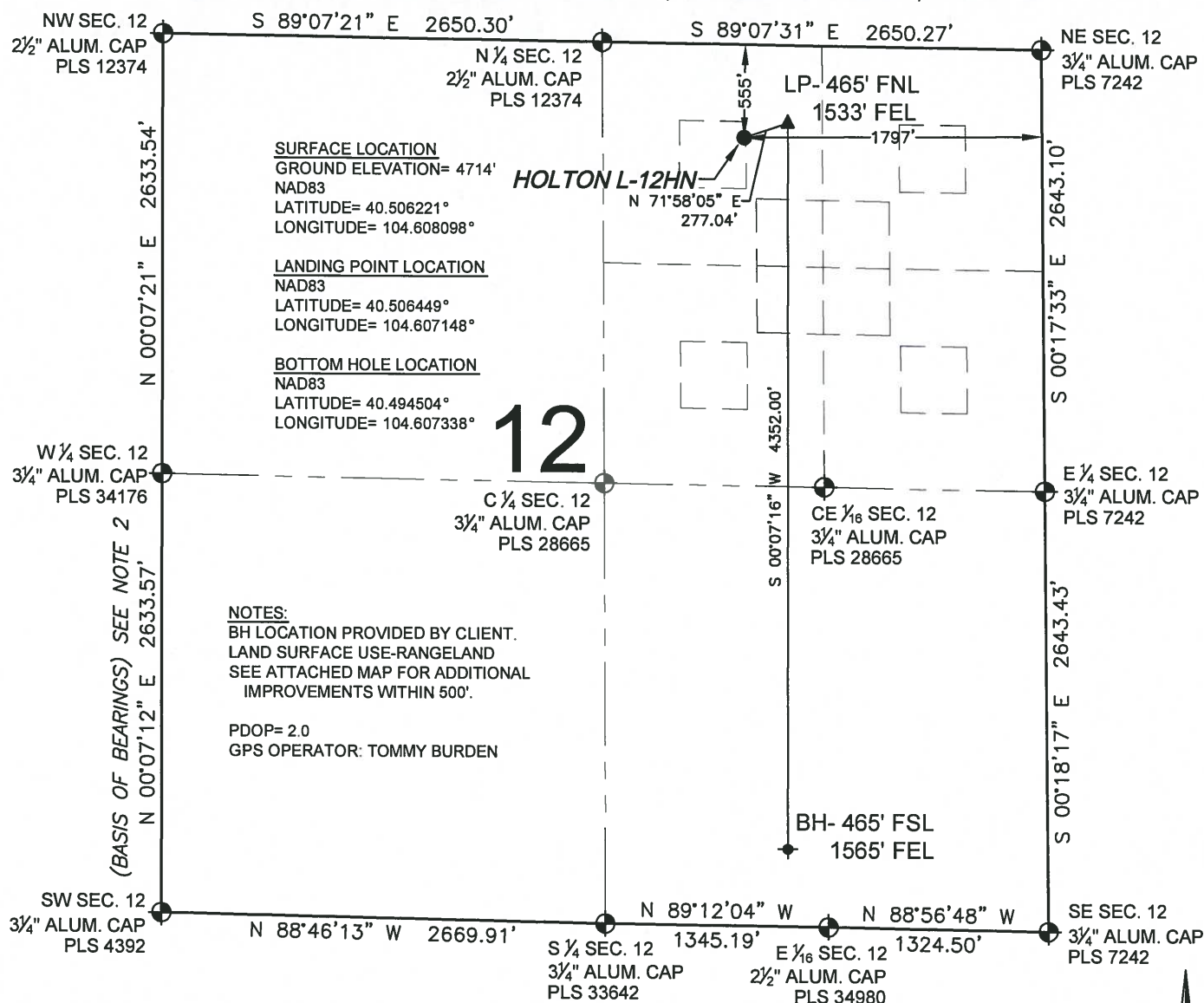
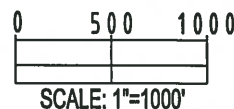


WELL LOCATION CERTIFICATE: HOLTON L-12HN
