WPX Energy is requesting permission to utilize Deep Earth Technology Incorporated's (DTI's) Cool-Ox™ process to pump approximately 15,000 gallons of Cool-Ox oxidizer into six dry treatment wells located at the RMV 216-21 workover pit in order to decrease the hydrocarbon concentrations in soil.

In June 2013, six soil borings were advanced, within the perimeter of the former workover pit, into the areas with the highest hydrocarbon concentrations. A dry well was completed at each boring site to accommodate future in-situ remediation. Well locations are displayed on the attached Figure 1. The baseline analytical data is summarized in Figure 2. The full analytical data, well installation summary and completion logs were included in the summary report submitted to COGCC on 7/3/2013 (COGCC Document # 400443248).

Upon the approval of this sundry notice, WPX would like to treat the six boring locations the week of 4/14/14.
