From the well head one 3" fiberglass flow line approximately 2647' to the tank battery which contains one separator (heater-treater). From separator two 3" fiberglass pipelines approximately 200' to 3-300 bbl oil tanks and 1-300 bbl water tank. Plus one 48" VOC combustion changer has been added.
