Operator has obtained an approved USR from Weld County for the subject Disposal Well Facility and related buildings/facilities.  
 Facilities will be within a walled containment area. Operator has listed 2 flash separation tanks (750 bbl), but one larger tank (1500 bbl) may be used instead. Tankage will include 22 water tanks (550 bbl), 4 oil tanks (500 bbl) and 2 gunbarrels (750 bbl). Primary facility fluid containment:  
 12 to 8" gradational concrete slab;  
 tank battery (18" x 4" concrete walls).  
 Secondary containment:  
 Poly liner under entire facility, including building, tank battery, truck loading pad;  
 Leaching detection - lysimeters or similar;  
 Sump with trash pumps to evacuate fluid collected on liners.
