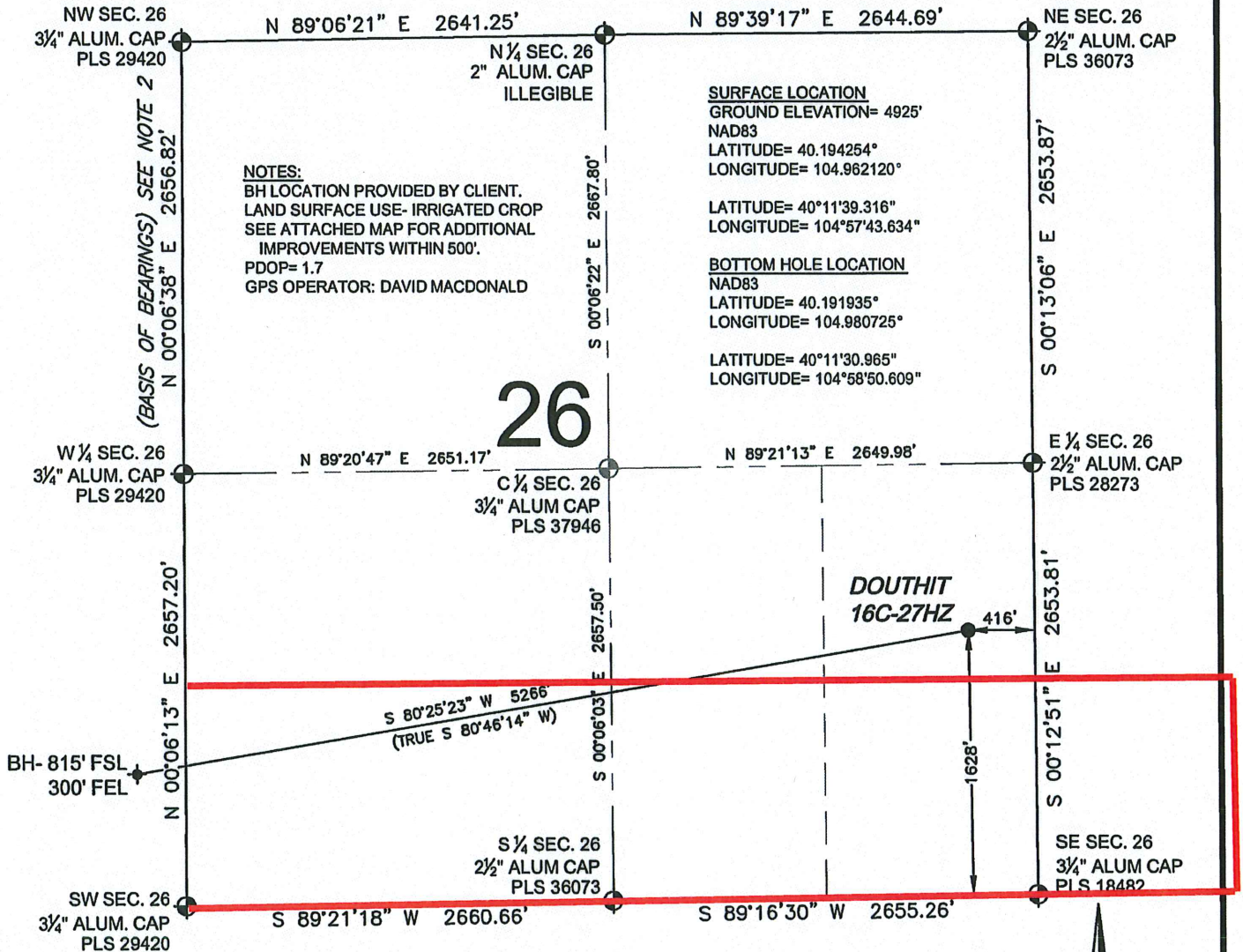

WELL DOUTHIT 16C-27HZ TO BE LOCATED 1628' FSL AND 416' FEL

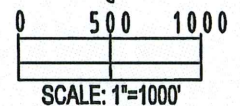

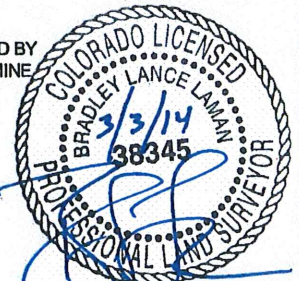

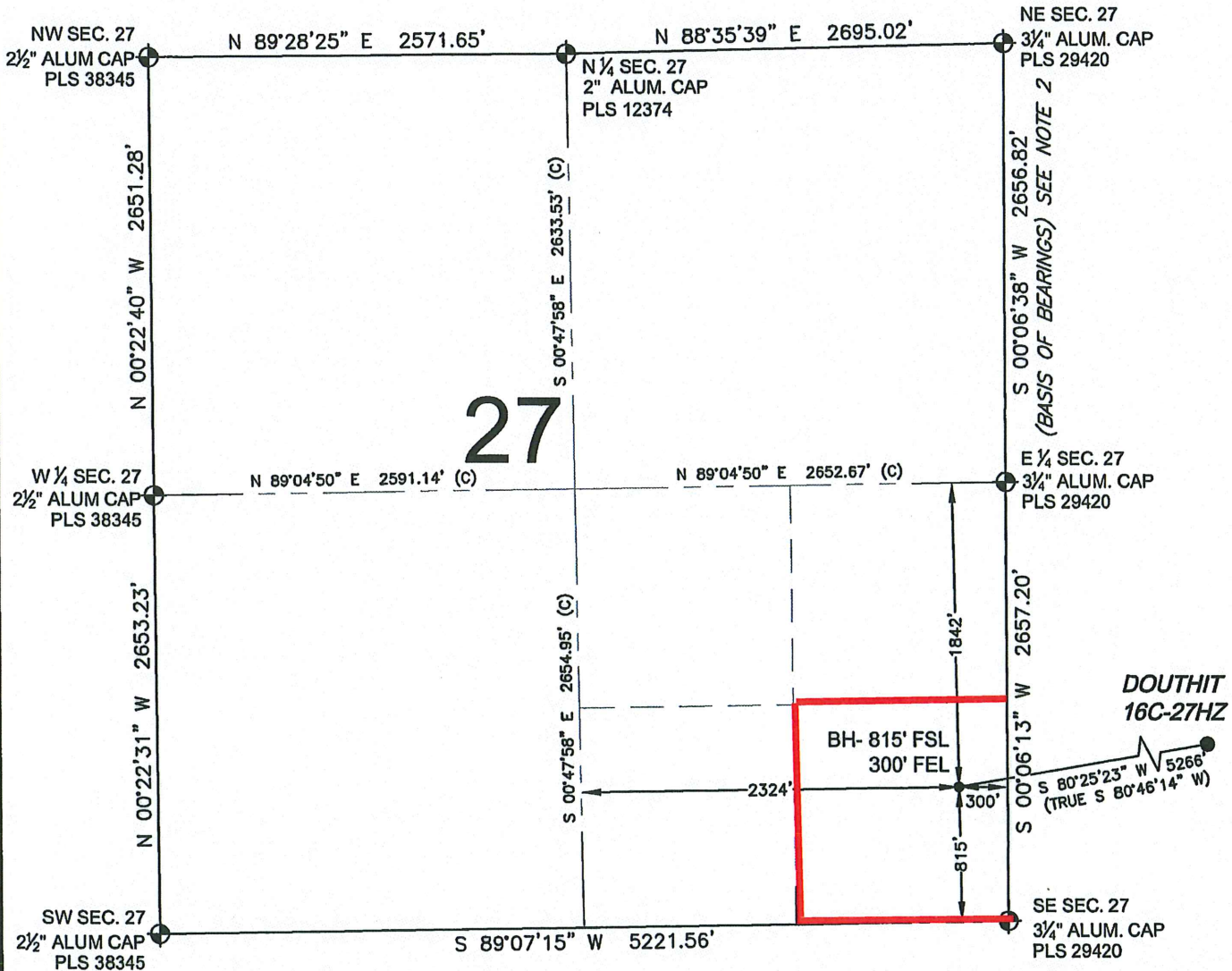
