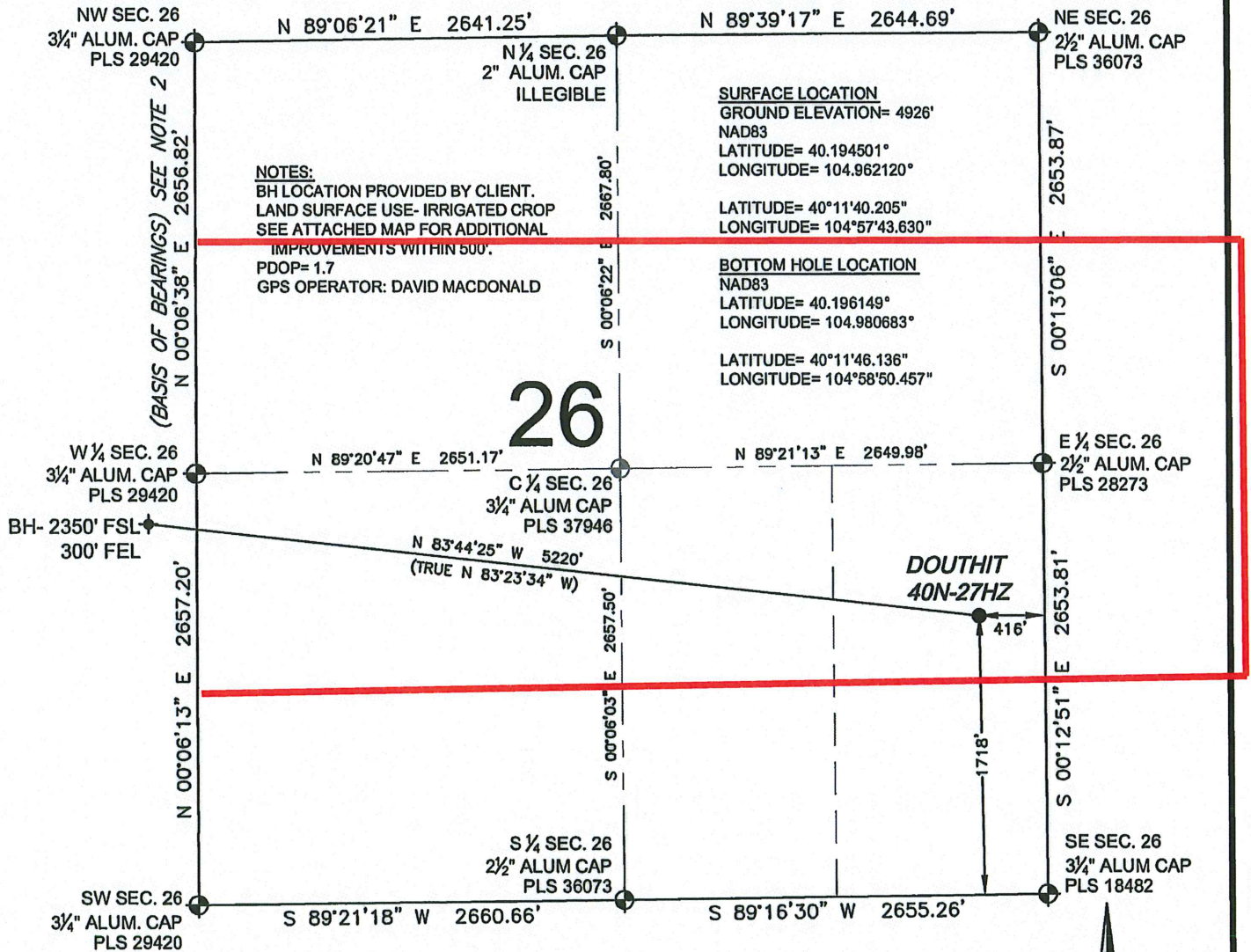

WELL DOUTHIT 40N-27HZ TO BE LOCATED 1718' FSL AND 416' FEL

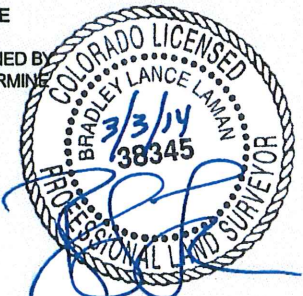
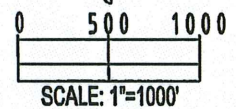
