WPX request permission to vent the surface bradenhead gas. Below find the following information:

- Surface Casing – 9 5/8" 36# set @ 1,163'
- Production Casing – 4 1/2" 11.6# set @ 8,751'
- Top of production cement – 5,174'
- Tubing – 2 3/8" 4.7# set @ 8,308'
- Completion – 6,432' – 8,499'

History- WPX spud well on 3/1/14. All initial bradenhead readings were 0 psi. We monitored the surface bradenhead pressure during the completion (4/9/2014 – 4/14/2014) and the pressure remained at 0 psi. We did not observe any bradenhead pressure during frac plug drillouts (completed 4/21/2014). At 5am on 4/22 the bradenhead pressure was at 0 psi. At 11 am 4/22 the bradenhead pressure was at 400 psi. It was bled down and only gas came to surface. It was shut back in and the pressure built back to 80 psi. It was bled off on 4/23 and shut back in. It pressured back to 23 psi over night and was handed over to production on 4/24. It pressured back to 90 psi after production took over. We bled it off and shut back in. At 7am on 4/25, the bradenhead pressure was at 340 psi. We bled it off and shut back in. At 7am on 4/26, the bradenhead pressure was at 410 psi. It was bled off and shut back in various times over the weekend. Only gas was observed. The pressure returned to about 400 psi every morning with. WPX would like to vent the surface bradenhead gas through a hard line to a tank for 90 days in attempt to dissipate the surface pressure. After the 90 days, we will perform a 14 day shut in and report the pressure. Any additional steps can be discussed at that time.
