11/29/11: Upon reclamation of the "Lease of interest" all pits, mouse and rat holes and cellars were backfilled and compaction alleviated. All segregated soil horizons were replaced to their original relative positions and contour, and was tilled adequately to re-establish proper seedbed. All debris, weeds, and other waste material were removed. Access road was closed, graded, recontoured, and compaction alleviated.
