XTO Energy Inc. would like to extend the approved Seismic Study being done on this well to an additional 5 year, this would allow us to continue the long term seismicity monitoring of the basin.

XTO would also lie to ask for a Variance to the MIT Rule 326 during the Seismic Study. This well has BPs @ 2200' & 1250' and passed an MIT on 05/21/2012, there is also solid cement behind peip (CBL doc #1460249).

XTO still plans to plug and abandon the wellbore after the Seismic Study is completed.
