The location was marked as sensitive as it is in the Upper Black Squirrel Creek Designated Ground Water Management area and Designated Basin as well as the Black Squirrel Aquifer. Agave Oil and Gas LLC is aware of the El Paso County requirements and will submit an El Paso County Oil and Gas Application at a later date. Reference Area photos will be taken and submitted at a later date when the snow has melted. The reference area latitude is 39.01447 and the longitude is -104.33179. The building unit that is 910' from the location is occupied and owned by the Surface Owner. They have been notified that the proposed location is within a 1,000' Buffer Zone. They have also signed a waiver, releasing Agave from the required 30 day period between receiving the notification and submitting the permit. The waiver is attached to this permit.
