- 1) Drill pipe was stuck in hole at 12,468. After unsuccessful attempts to recover drill pipe and BHA, with drill pipe parting at 7,062' it was determined that it was not economical to continue fishing operations, and the possibilities of recovering more drill pipe are less than 10% it was determined to P&A the well.
- 2) Number of the wells on the pad is increasing from 3 to 4. lost hole rig skid
- 3) Alles 22S-432 - P&A'd well
- 4) Alles 22S-232 - Replacement Well
- 5) No additional impact on location is planned, no additional surface disturbance will be made.
- 6) Verbal/Email approval to plug, skid rig, and spud replacement well given by Diana Burn on 3/28/14
