CAUSE INFORMATION: Caller recently reported this company dumping produced water at a place a ways up the road. Caller thinks people from the state came and took soil samples and told the company to stop dumping there on 3/2/14. At that time, the company just changed to dumping several loads per hour at a gravel pit located approx 10 yards from the New Mexico border on Hwy 171. This gravel pit is also owned by Crossfire. However, nothing is being done to prevent the produced water from soaking into the ground. This location is < 1/2 mile from the Pine River, and <1.5 mile from the Navajo Lake.
