This well is in a previously untested, existing production is greater than 1 mile distant, bench of the Niobrara. The effects of the other well during the drilling and completion phases are not understood. We believe there is enough risk and unknowns in radically combining these concepts that Bonanza Creek would be at a disadvantage to our competitors should we not be allowed the minimalist protections provided by withholding key information for the proscribed confidentiality period.
