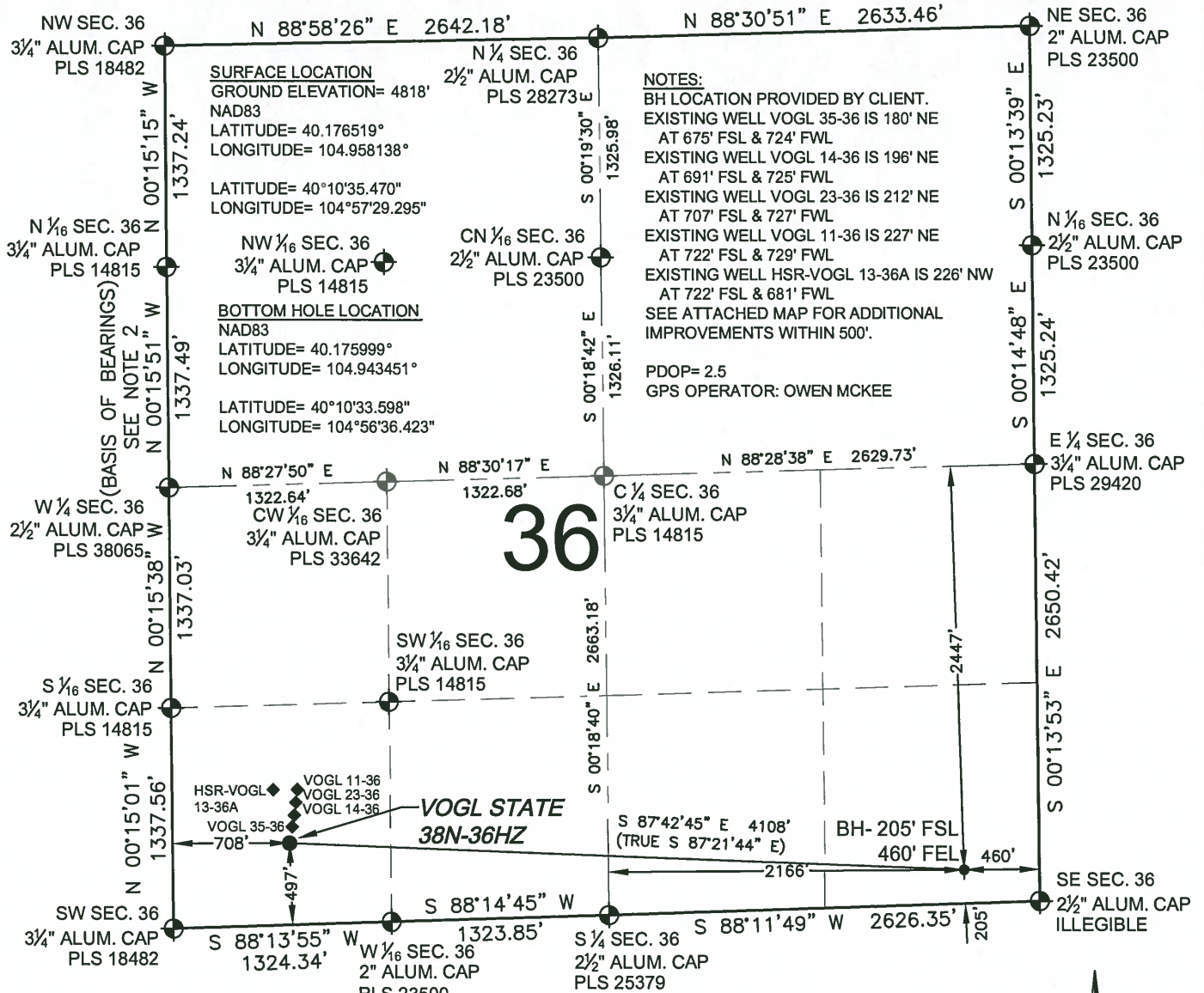


# WELL LOCATION CERTIFICATE: VOGL STATE 38N-36HZ

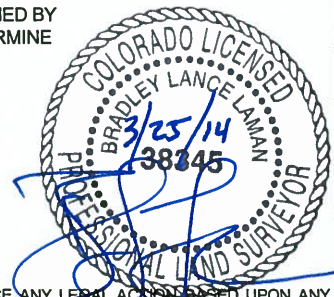
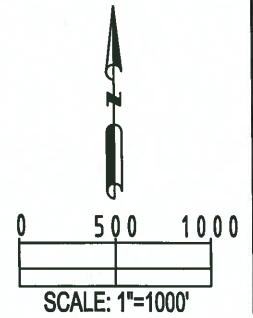
