This well site had a COGCC inspection (Doc #674600022) on 2/20/14 citing corrective action to re-establish proper drainage through the culvert and underneath the lease road and to clean up and replace lost roadbase and gravel. BP is scheduled to complete the work on the road by the due date of 5/26/14.
