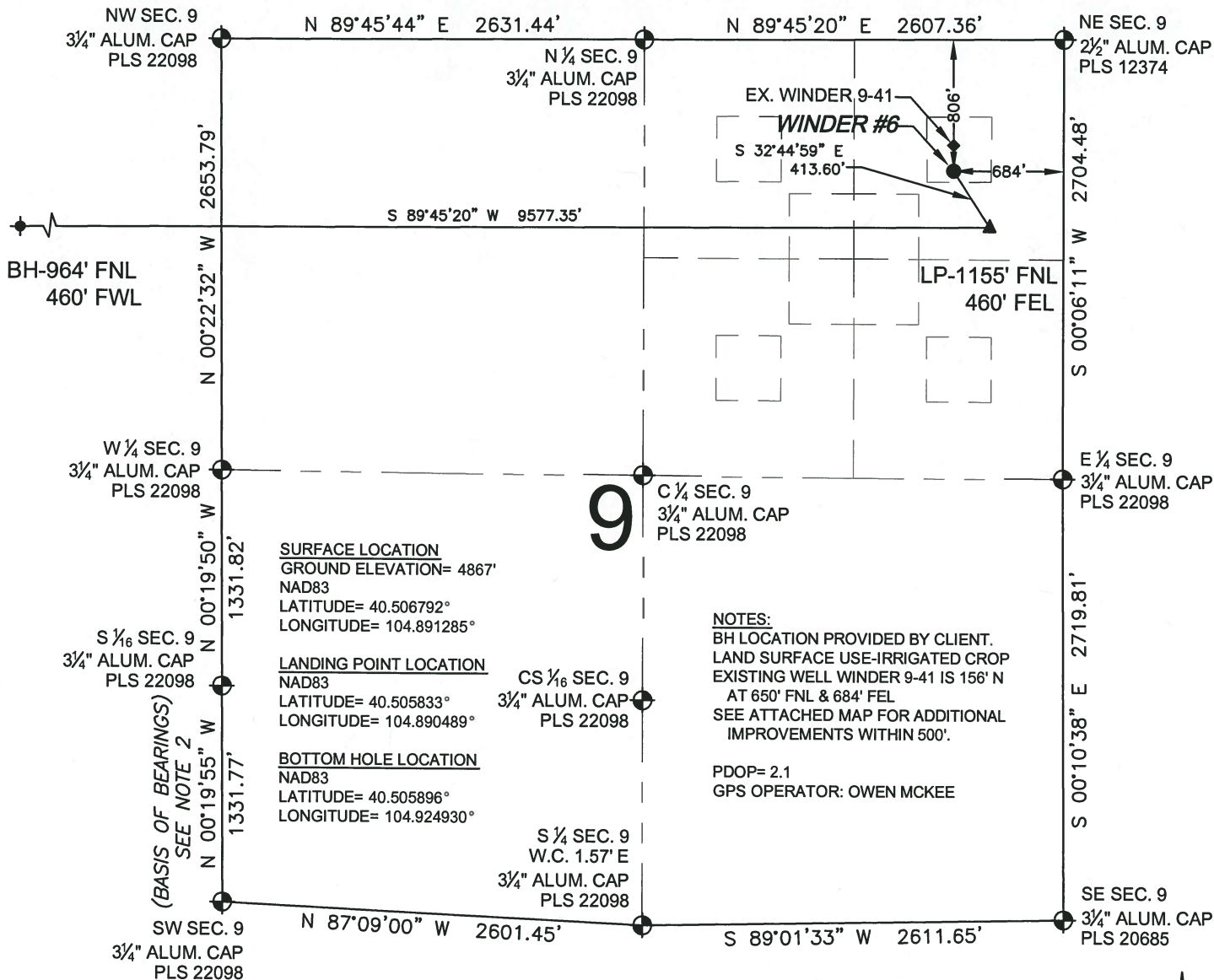


WELL LOCATION CERTIFICATE: WINDER #6

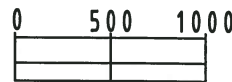

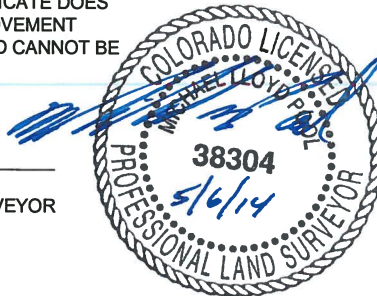

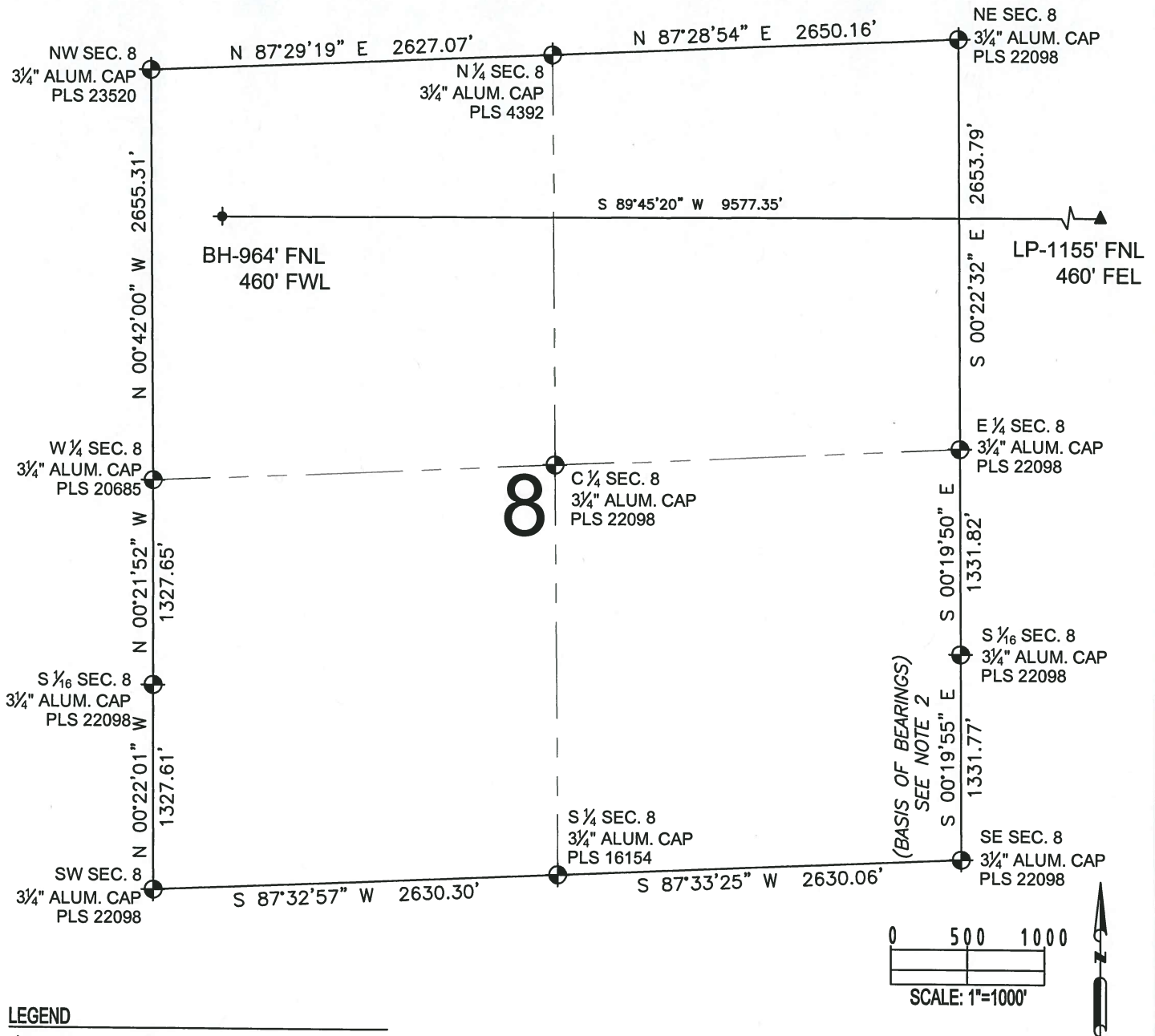
