Fabrianna,

I have reviewed the referenced Form 2A Oil & Gas Location Assessment and have the following comments.

- 1) Your pipeline description is not adequate. Please provide the number, size, and material of each pipeline that will go from the truck loading area to the tank battery. Also indicate if they are buried or not and if they will be pressurized.
- 2) In the Facilities section you have indicated there will be no Drilling Pits, yet you have also indicated that a closed loop system will not be used for the drilling fluids. This seems contradictory. Please provide information on how the drilling fluids will be handled on this oil and gas location.
- 3) Your Location Drawing does not meet our requirements. Per COGCC Rule 303.b.(3)D, the Location Drawing shall include all visible improvements within 500 feet of the proposed oil and gas location, with a horizontal distance and approximate bearing from the oil and gas location. Visible improvements shall include, but not limited to, all publicly maintained roads and major above ground utility lines. In the Cultural Distance section you have indicated the distance to the nearest Public Road and Above Ground Utility is 220 feet and 280 feet, respectively. These two Cultural items are not identified on your Location Drawing. Please provide a revised Location Drawing showing the distance and approximate bearing to all visible improvements with 500 feet of the oil and gas location.

1. There will be four (4); six-inch (6"); Schedule 80 PCV pipelines that will go from the truck loading area to the tank battery. They will not be buried. They will be overhead and accessible for future replacement. They will be pressurized at 35 PSI (max).
2. We WILL be using a closed loop system.
3. We are amending the Location Drawing and I will get that to you as soon as possible.
