


WELL LOCATION CERTIFICATE

PRONGHORN K-O-12HNC



In accordance with a request from RANDY EDELEN with BONANZA CREEK ENERGY, INC., King Surveyors has determined the surface location of PRONGHORN K-O-12HNC to be 200' from the NORTH line and 2681' from the WEST line and the bottom hole to be 470' from the SOUTH line and 2679' from the WEST line, as measured at right angles, from the section lines of Section 12, Township 5 North, Range 61 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 1-17-2014, for and on behalf of BONANZA CREEK ENERGY, INC., that this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.
