This sundry serves as the required follow up to the high bradenhead reading recorded on 5/6/14 during the completion of this well. We believe that the bradenhead spike occurred due to thermal gas expansion and was an isolated incident. As of 5/14/14 at 19:45 the pressure remained at 0 psi. Kerr-McGee proposes to continue monitoring the bradenhead pressure over the course of 30 days. Please see the attached supporting documentation.
