On Friday, May 16, 2014, at 11AM I was informed of this unplanned sidetrack for this well.

On Thursday, May 15, 2014, the drill string got stuck. While tripping out of hole to work on the tight spot the downhole motor parted resulting in part of the motor and bit stuck in hole. WPX was able to retrieve the rest of the BHA. WPX received a verbal approval from David Andrews on Friday, May 16, 2014 at 7:40 AM for the sidetrack. The SHL and BHL will stay the same. Attached find the sidetrack procedure. The new TD is 8183' MD. The original TD was 8232' MD.

Per David's order, "This is your approval to proceed with the sidetrack. Please coordinate with Bill Yokley (COGCC Permitting, Denver office) on timely submission of the required forms and supporting documentation, as shown on the attached guidance document.
