Daily Summary

3/6/14

MI and tried to rig up, dogs wouldn't kick out on scope. SDFN and will go again in daylight.

3/7/14

RU and pull rods and tubing. Tubing parted deep, stator and possible one or two jts left in hole. Called Kevin, decision made to leave fish as it was below plug level. Ran in hole with plug but would not set, tripped out of hole and plug and tool had 1/8" steel tubing wrapped around it from an old downhole chemical drip. Cut off 1/8" tubing and ran back in with plug, setting at 870', TOOH and run in with dump bailer and 4 sks cement to get two onto plug. TOOH and run in with second plug, setting at 157', pulled off plug a few feet and pumped 15 sks cement on top of plug, pulled up above cement and loaded hole with water. RD and move to the 14-3.

3/27/14

ECWS cut off casing 4' below ground level.
ECWS ran in with 1' pipe and topped off annulus and 5.5" to surface, 4 sks.

3/28/14

Took Topar welder to location and welded 8 5/8 cap on top of casing, put well number, date, and RRR on cap. .Will backfill at later date. Move to next location




