Comments This Form 2 Re-file has been revised from the original approved Form 2 APD (BAT 22B-24-07-96). The well name is being changed to BAT 14A-24-07-96. The SHL, BHL, casing and cement program and TD have been updated. The BMPs for this well were approved with the Speakman A Pad (Location ID # 422301). The pad has been built, and there will not be additional surface disturbance at the pad location. The location does not require a variance from any of the rules listed in Rule 306.d.(1).(A).(ii). The location is not within a wildlife Restricted Surface Occupancy Area. I certify that there have been no changes on land use, lease description. This well is producing from Federal Lease COC027825 which is part of the 588 acre unit created by Spacing Order 139-116. The minerals in this spacing unit are Federal and fee.
