There are no changes from the original approved APD. Land use and lease description have not changed from what was previously approved. This portion of the pad has not been constructed. There will be no additional surface disturbance from what was previously permitted on the 2A. If this portion of the pad is not constructed prior to the expiration of the current 2A (expires 4/13/2015), a new 2A will be refiled prior to constructing the pad.
