## COMMENTS:

As requested by Carlos Lujan via e-mail on October 30, 2013, the varience request submitted via Sundry Notice Form 4 (Doc# 400476417) for the exceedance of Benzo(a)pyrene within the excavation was denied. Additional remediation was performed during the fall of 2013 and resampled for PAH analysis on November 15, 2013. Due to winter weather, disposal of the impacted soils could not take place until April 10, 2014. Soils within the excavation now satisfy COGCC Table 910-1 concentrations and the excavated impacted soils have been disposed to the Garfield County Landfill. Ursa is requesting closure of the spill (COGCC tracking # 2232746).
