Attached are the laboratory reports and the sample location map for the soil samples collected from the excavated area, landfarm, and nearby non-impacted native soil in order to close the produced water release incident that occurred at the RWF 32-36 well pad and was discovered on February 20, 2014.

- One grab sample was collected from the bottom of the excavation and one composite sample was collected from the excavated material landfarm. Both samples were analyzed for the constituents listed in Table 910-1.
 - Five grab samples were collected from nearby non-impacted, native soil to establish the background concentrations for arsenic. In accordance with the COGCC Rule 910.b.(3)E, one grab sample was analyzed for inorganics to establish background soil conditions. As the attached lab reports indicate, all constituents of concern listed in the COGCC Table 910-1 tested below the cleanup requirements or below the background concentrations with the exception of the inorganics. Therefore, in accordance with COGCC guideline Q32 regarding inorganics, the RWF 32-36 well pad will be covered with 3' of clean soil during final reclamation of the site in order to account for this exceedance.
- Based on these results, WPX respectfully requests closure of this incident.
