**RE: Request for Waiver – Waiver of minimum intrawell distance, Rule 318A.m.  
Kerr-McGee Oil & Gas Onshore LP  
Bidding 36C-35HZ Horizontal Well  
SWSE of Section 35, Township 2 North, Range 66 West, 6th P.M. (BHL)  
Weld County, Colorado**

To Whom It May Concern,

Please be advised that Kerr-McGee Oil & Gas Onshore LP (“Kerr-McGee”) is requesting a Rule 318A.m. waiver for the Bidding 36C-35HZ Well (the “Kerr-McGee Well”). The Kerr-McGee Well is a horizontal well which Kerr-McGee has drilled on the above-referenced lands and intends to complete for production from the Codell Formation with a surface location 350’ FSL and 1,979’ FEL in the SWSE of Section 26, Township 2 North, Range 66 West, 6<sup>th</sup> P.M., and bottom hole location 27’ FSL and 2,338’ FEL in the SESW of Section 35, Township 2 North, Range 66 West, 6<sup>th</sup> P.M. Kerr-McGee is seeking waiver of the Rule 318A.m. 150’ intrawell distance for the Kerr-McGee Well due to encroachment by the Kerr-McGee Well to a point approximately 4’ from Encana Oil & Gas (USA) Inc.’s (“Encana”) Rodman Bruntz 2E-26H Well (the “Encana Well”), a horizontal well drilled from a surface location 572’ FNL and 2,077’ FWL in the NENW of Section 26, Township 2 North, Range 66 West, 6<sup>th</sup> P.M., with the bottom hole location at 587’ FSL and 2,485’ FWL in the SENW of Section 35, Township 2 North, Range 66 West, 6<sup>th</sup> P.M., yet to be completed in the Niobrara Formation. Please see attached Exhibit A for an approximated illustration depicting a two-dimensional view of the wellbores at issue.

The Kerr-McGee Well vertically encroached upon the lateral portion of the Encana Well as it positioned the Kerr-McGee Well for entry into the Codell Formation. Encana hereby agrees that it shall not perforate and complete the Encana Well at any point which is less than 50’ north or south of the vertical portion of the Kerr-McGee Well (described as “Non-Completed Interval” on attached Exhibit B). Kerr-McGee and Encana will enter into a separate indemnification agreement to address rights and remedies which may result from this encroachment.

The purpose of this letter is to obtain Encana’s waiver in writing as operator of the encroached upon well (the Encana Well) as provided for by Rule 318A.m. Time is of the essence in this matter and it is requested that you sign and return this letter/waiver as soon as possible, but no later than Tuesday, May 20, 2014.

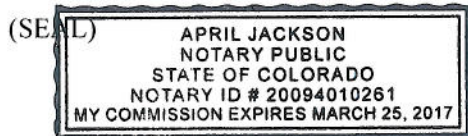

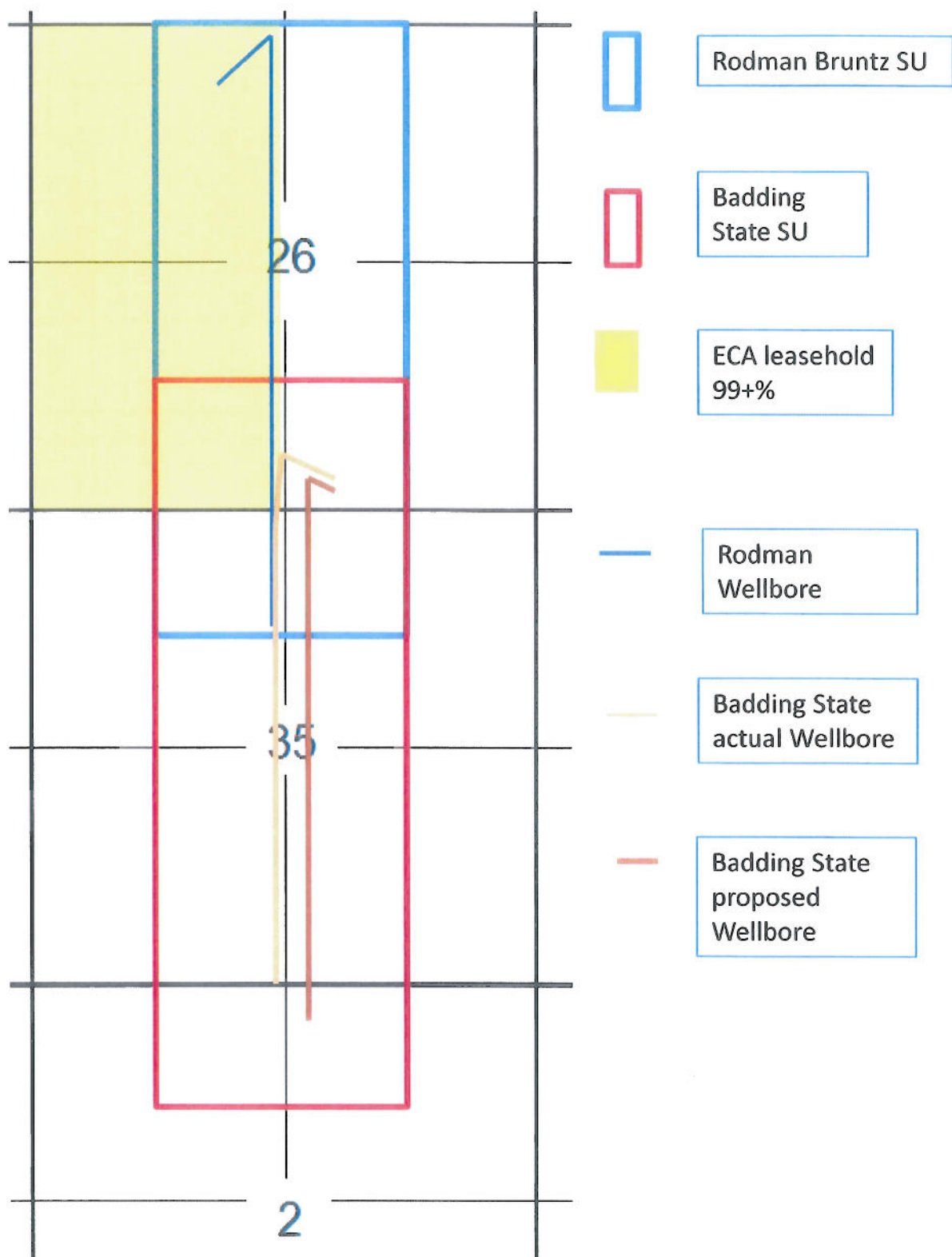
