- 1) MIRU workover rig
- 2) Unset packer and POOH
- 3) Set up wireline, RIH and set a CIBP w/ 2 sacks of cement @ 6,300'
- 4) RIH with packer and set at 4,775' pressure test below packer to 7,000 psi
- 6) POOH with packer and complete stages per completion design
- 7) RIH with bit and drill out plugs
- 8) RIH with packer and land at 4,650'
- 9) Pressure test backside to MAIP and schedule MIT
- 10) Submit subsequent report
