Blue Chip Oil utilizes sediment containment systems which include silt fencing, straw bales, berms, erosion control blankets, etc. BMP's used will vary according to site slopes, drainage patterns, and other site-specific conditions. A copy of the SWMP is kept in our office.</p> <p>Spill Prevention Control and Countermeasure (SPCC) is in place to address any spills associated with Blue Clip Oil &amp; gas operations.</p> <p>Any waste and trash will remove from the site for disposal.</p> <p>Routine maintenance will be limited to fueling and lubrication of equipment. Drip pans will be used during fueling and maintenance to contain spills or leaks. Hay bales will be placed as sound barriers on location that are close to residence as reured.</p>
