Comments	<p>Other Disposal Description: Drilling fluids disposal: KMG will reuse water-based drilling fluids to the maximum extent at which point they will either be land applied or taken to a licensed, commercial disposal site; decided upon based off of laboratory analysis of fluids. Cuttings disposal: If the surface owner authorizes, and if it is feasible for this location at the time of drilling, water-based cuttings will be disposed of onsite using bioremediation/solidification product. If the surface owner does not authorize onsite disposal and/or it is not feasible for this location at the time of drilling, water-based cuttings will be disposed of using a Centralized E&P Waste Management facility or a private spread field.</p> <p>Flow Lines: Six additional flow lines will flow to the production facility location. During production, flow direction in the flow lines is from the well head to the production facility. The size of flow lines is typically 2". Flow lines will be constructed from steel pipe, buried, and will equal the distance between the well heads and the tank battery, approximately 2500'.</p> <p>Six additional fuel gas supply lines will also be installed from the well head to the production facility. During operation flow direction in the supply lines will be from the production facility to the well head. The size of the supply lines is typically 1". Supply lines will be constructed from poly or steel pipe, buried, and will equal the distance between the well heads and the tank battery, approximately 2500'.</p> <p>Gas lift lines are also occasionally installed (one per well) from the well head to the production facility. During operation flow direction in the gas lift lines will be from the production facility to the well head. The size of the gas lift lines is typically 2". Gas lift lines will be constructed from steel pipe, buried, and will equal the distance between the well heads and the tank battery, approximately 2500'.</p>

1	Planning	The nearest building unit is located 1965' away from this oil and gas location, therefore it is not within a Designated Setback Location and is exempt from 604.c.
2	Planning	Anadarko has developed a comprehensive Emergency Response & Oil Spill Contingency Plan that outlines a command structure for response personnel, mobilization of employee and response contractors, and notification procedures for local, state, and federal regulatory agencies. An inventory of all wells and production facilities in the floodplain, with associated elevation, will be maintained and provided to the COGCC annually and upon request. Facilities in floodplains will be conducted annually for flood preparedness.
3	Construction	Slopes of pad and lease roads will be stabilized with riprap, vegetation, or other erosion control methods. Structural guards or barriers will be installed upstream (south) of wellheads to deflect debris in the event of a flood. (Examples include 4" pipe with cement, cattle guard style, 4" bollards) Automation will be installed to allow for remote shut in of wells. All flowlines will be buried a minimum of 4 feet below ground surface.
