This well was completed in April 2013 and an extension to interim reclamation was previously granted through May 2014. BBC still plans to re-occupy this pad for additional drilling and is requesting an extension to August of 2015. All stockpiled soils shall be protected from degradation and best management practices to prevent weed establishment and to maintain soil microbial activity shall be implemented.
