Noble Energy, Inc. ("NEI") is planning to drill the captioned boundary well in accordance with the provisions of COGCC Rule 318A.e.

NEI's proposed wellbore spacing unit consists of the Sec 1: S/2N/2, N/2S/2, Sec 2: S/2N/2, N/2S/2, Sec 3: NE/4SE/4, SE/4NE/4, T4N, R65W, creating a 720-acre wellbore spacing unit for the Niobrara formation. 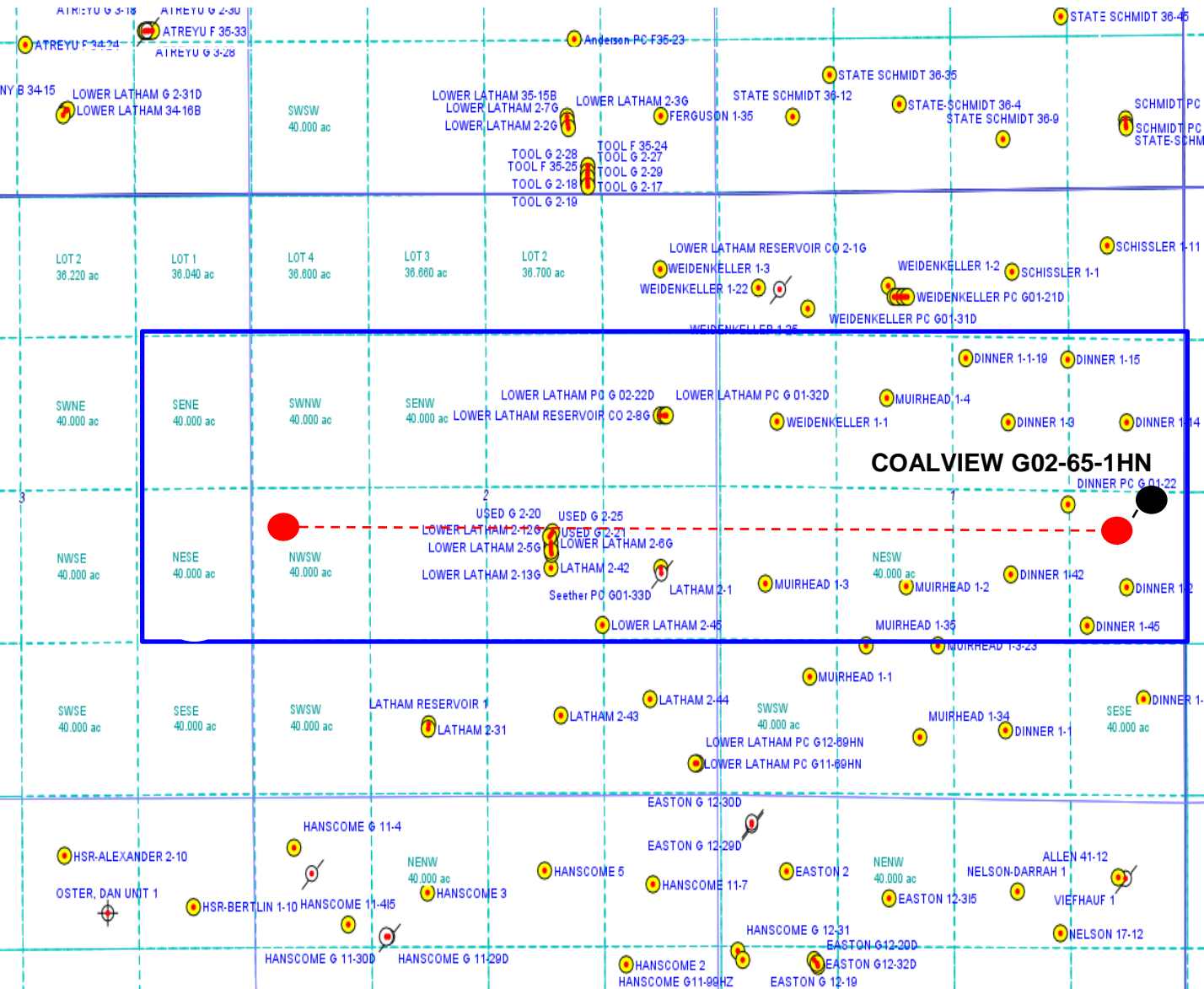

Bottom Hole Location

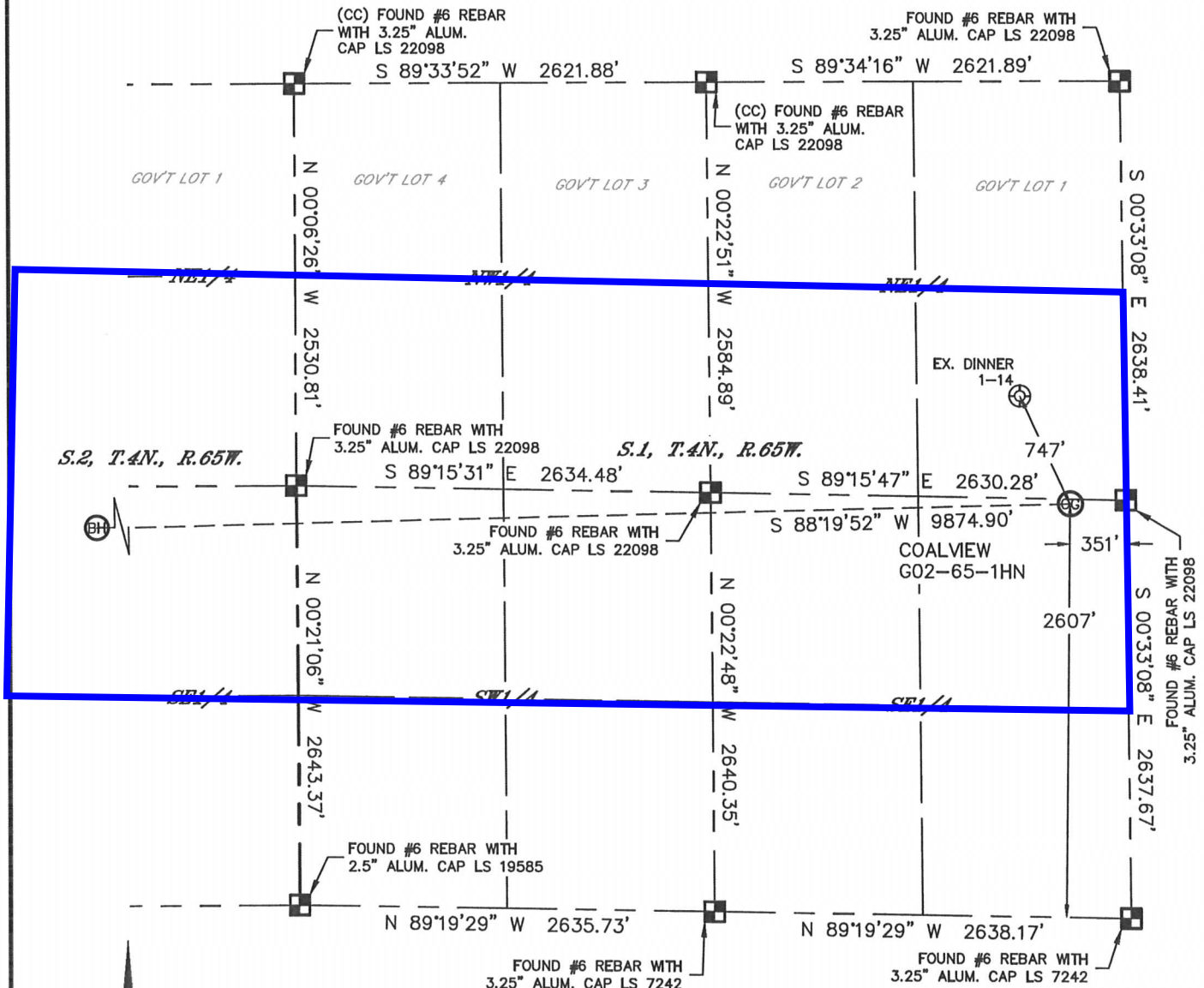

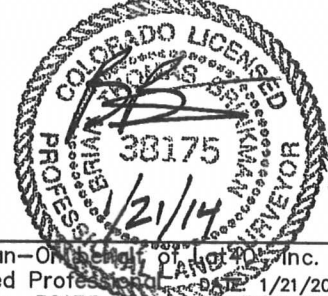

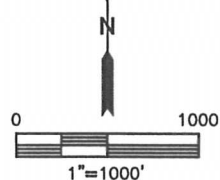
