## COMMENTS:

WPX Energy request permission to vent the bradenhead pressure. After performing two cement squeezes and pumping a total of 175 sks of cement, and reducing the bradenhead pressure to 170 psi from 205 psi, we would like permission to vent bradenhead gas to a tank, and attempt to de-pressurize the multiple sand bodies between new top of cement and the surface casing shoe, which may have been charged from gas prior to the squeezes. Based on the pressure reduction, and 150 ft of very good cement bond (FMC CBL 12May2014), we believe this venting will result in bradenhead pressure returning to acceptable levels.

Below find the post bradenhead squeeze summary:

Service rig arrive on location, found bradenhead pressure to be 205 psi. RIH with tubing, set retrievable bridge plug at 2628', dumped 2 buckets of sand. Perforate w/ 4 shots, 90° phasing at 2530', establish injection rate of 0.75 bpm at 1500 psi, pumped 10 bbls 7.5% HCL, got an injection rate of 2 bpm at 800 psi. Set composite cement retainer at 2474', pump 20 bbl mud flush, 5 bbl water spacer, 50 sks, 10.2 bbls of 16 ppg cement, followed by 50 sks, 8.9 bbls of 17 ppg cement, displace with 9.5 bbls water. Wait on cement 22.5 hrs, drill through retainer and tag cement at 2464', drilled cement to 2562', pressure tested to 1000 psi, pressure bled down, ordered cement for squeeze #2. Set retainer at 2480', establish injection rate of 1.34 bpm at 1500 psi, spot cement down tubing and sting into retainer, pump 75 sks, 7 bbls, 17 ppg cement and displace with 9.5 bbls of water, shut down and hestation squeeze for 1 hr until cement locked up, wait on cement 70 hrs, drill retainer and tag hard cement at 2480', drill to 2580', pressure tests to 1000 psi all held. Run FMC CBL from 0 - 2550', showed at least 150' of very good cement bond.
