Form 2A Amendment: Please note Encana is the surface and mineral owner at this location. Encana requests an increase from initial surface disturbance area from 6.73 acres to 11.1 acres. The interim reclamation area will slightly increase from 1.72 acres to 1.9 acres. The revised location drawings and construction lay out plans have been attached for reference. This pad is included as part of the WMP. The K04 596 Pad will be reclaimed to the adjacent area to the Northwest.
