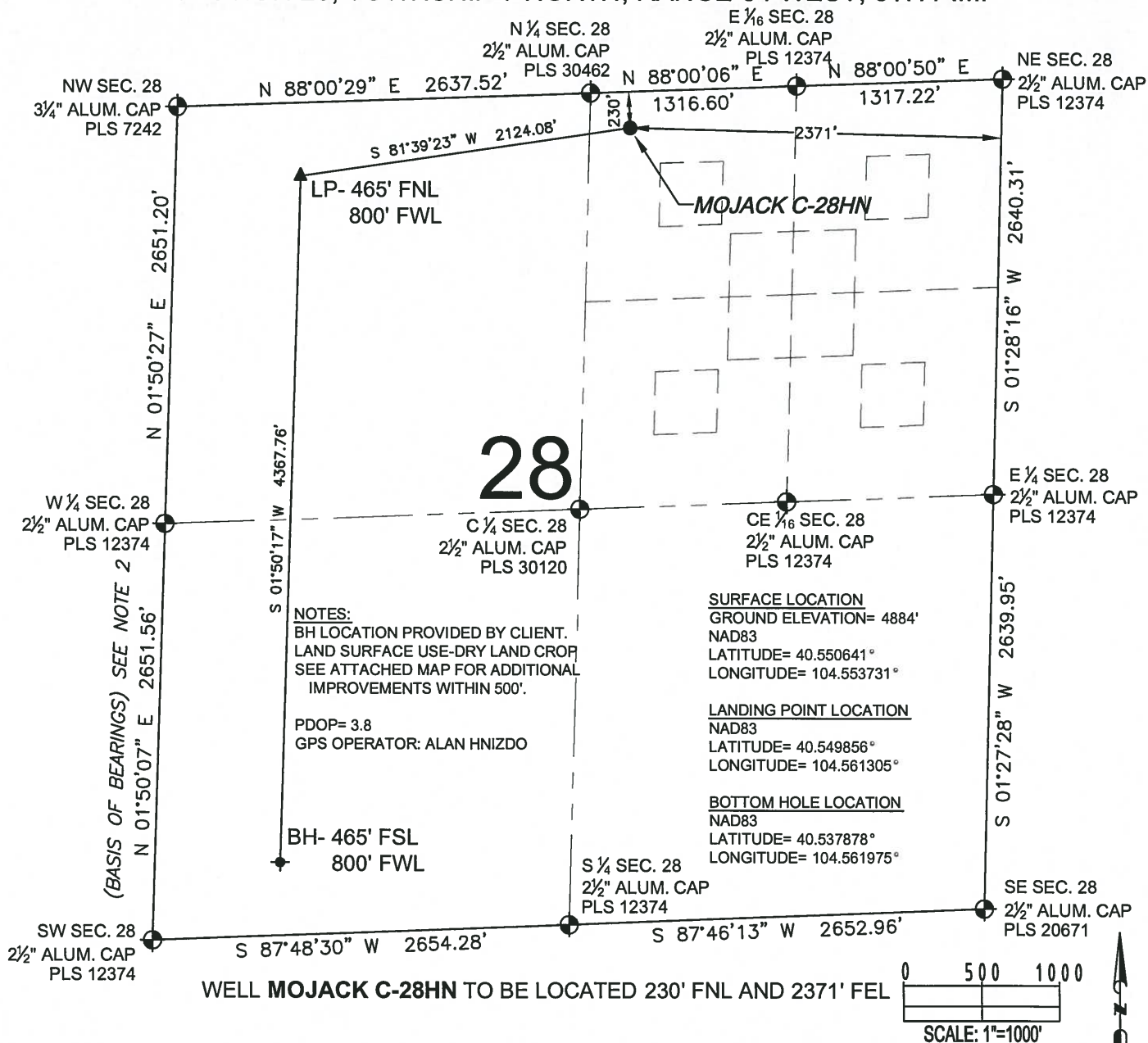


WELL LOCATION CERTIFICATE: MOJACK C-28HN

LEGEND

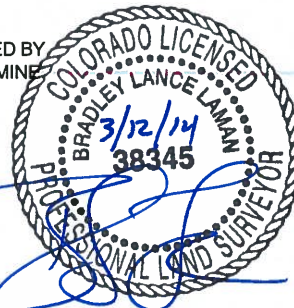
- = EXISTING MONUMENT
