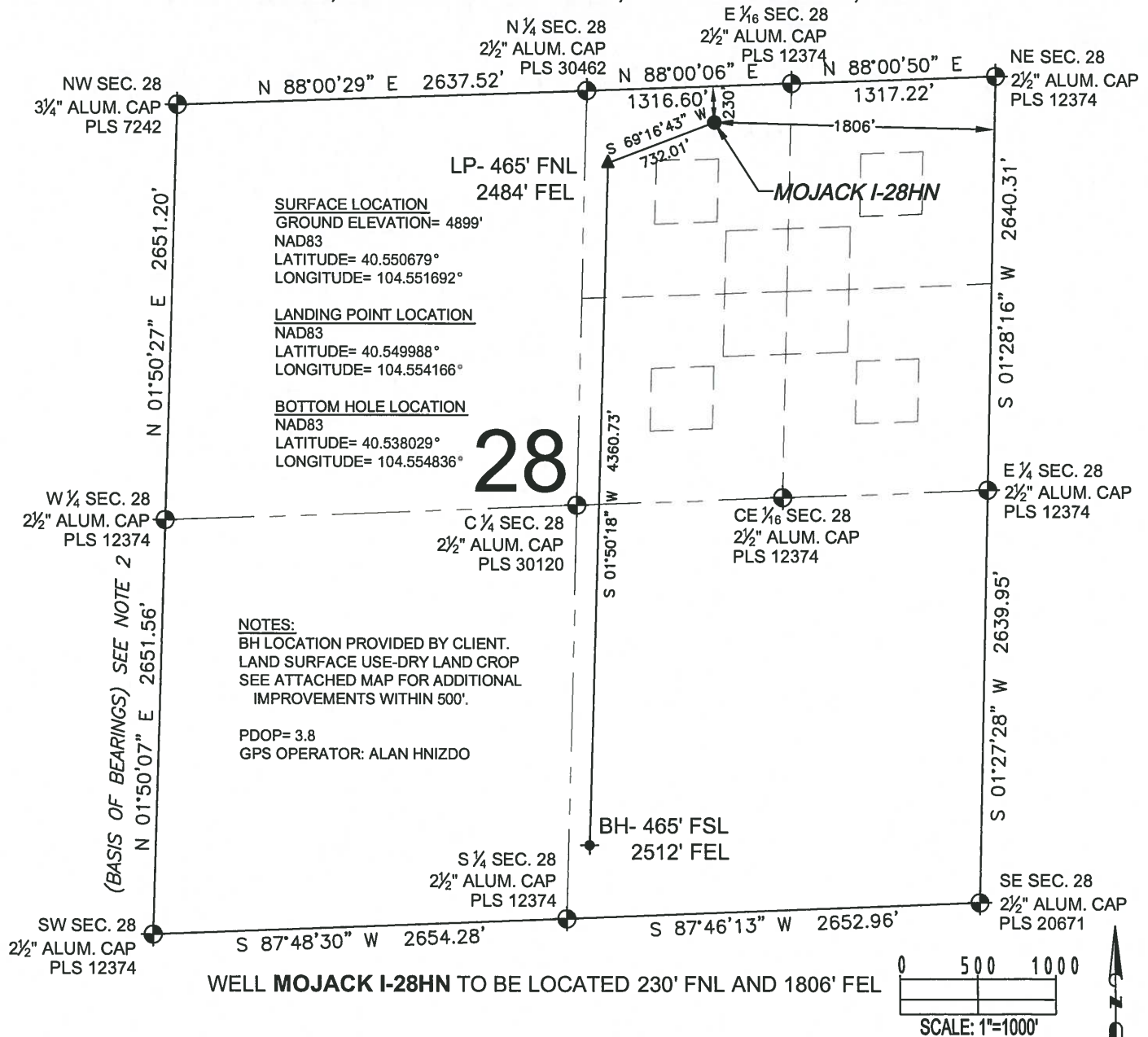


WELL LOCATION CERTIFICATE: MOJACK I-28HN

LEGEND

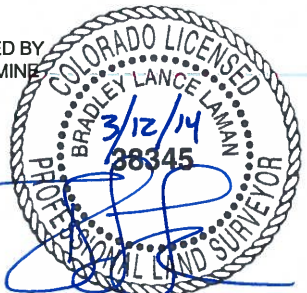
- = EXISTING MONUMENT
