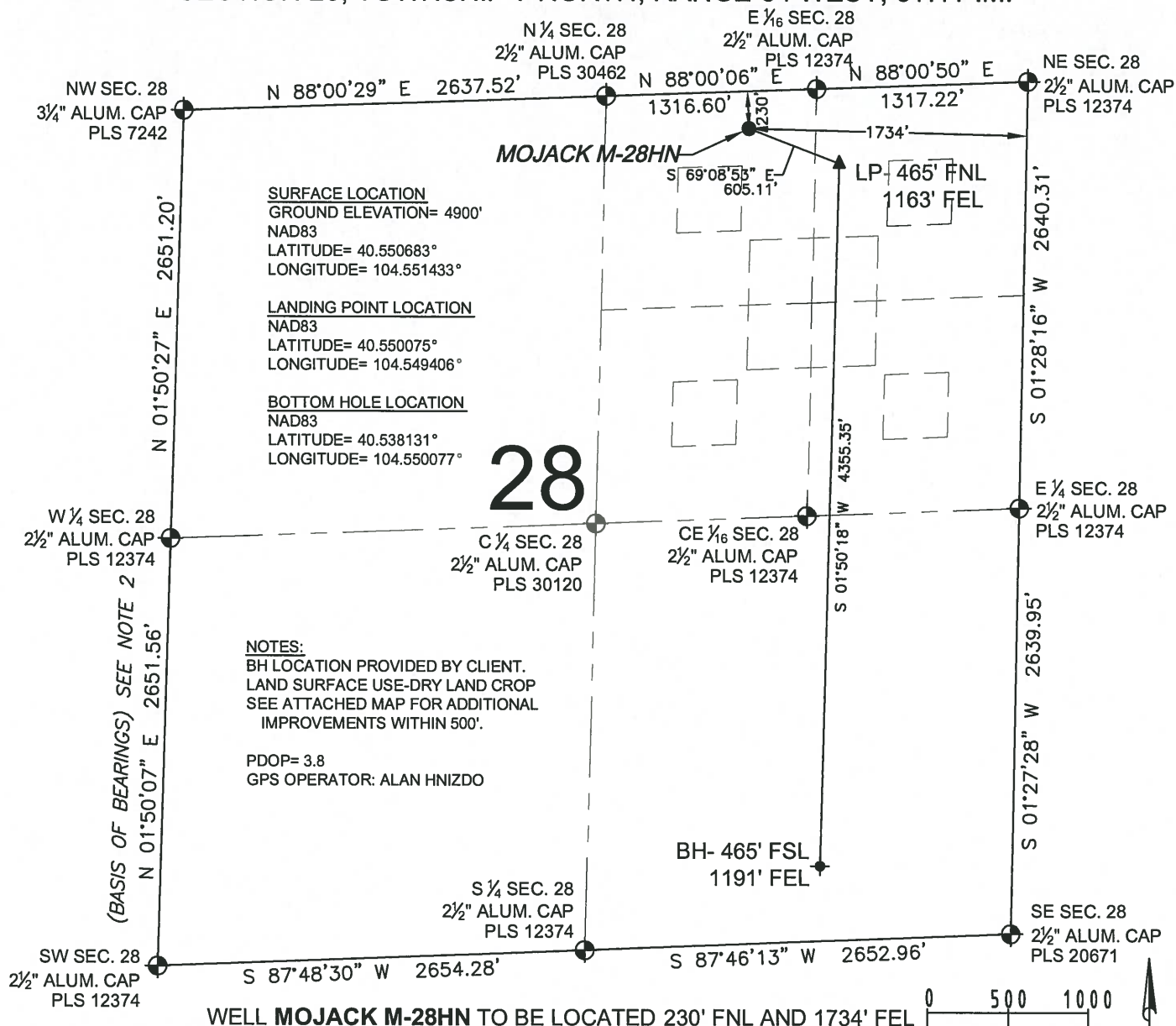


WELL LOCATION CERTIFICATE: MOJACK M-28HN

LEGEND

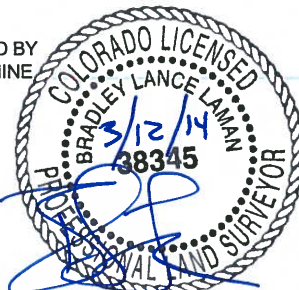
- = EXISTING MONUMENT
