Bayswater Exploration & Production, LLC (Bayswater) is planning to drill 8 horizontal wells on the above referenced pad to the formations as follows:

Kaiser A-10HN will be drilled to the Niobrara Formation
Kaiser B-10HC will be drilled to the Codell Formation
Kaiser C-10HN will be drilled to the Niobrara Formation
Kaiser D-10HN will be drilled to the Niobrara Formation
Kaiser E-10HN will be drilled to the Niobrara Formation
Kaiser F-10HN will be drilled to the Niobrara Formation
Kaiser G-10HN will be drilled to the Niobrara Formation
Kaiser H-10HC will be drilled to the Codell Formation

The surface locations of Bayswater's proposed wells have been staked outside of the COGCC Rule 318A.a. Greater Wattenberg Area (GWA) Drilling Window and are being permitted as exception locations. In addition, under the COGCC Rule 318A.c. any new Twinning well is to be located within 50 feet of an existing well. Bayswater's proposed wells are located approximately 335 feet from the nearest Oil and Gas well. Bayswater has obtained written permission from the surface owners by way of signed waivers.

Bayswater respectfully requests the COGCC to review the enclosed information and approve the requested exception location waiver and Application for Permit to Drill for the wells on the subject pad. Many thanks.
