NEI's proposed wellbore spacing unit consists of the SE/4SE/4 of Sec. 13, T4N, R65W, E/2E/2 of Sec. 24, T4N, R65W, E/2E/2 of Sec. 25, T4N, R65W, SW/4SW/4 of Sec. 18, T4N, R64W, W/2W/2 of Sec. 19, T4N, R64W, W/2W/2 of Sec. 30, T4N, R64W. creating a 720-acre wellbore spacing unit for the Niobrara formation. NEI is not the only owner within the proposed wellbore spacing unit and as such provided notice to the remaining owner(s) within said proposed spacing unit as required under COGCC Rule 318A(I).e(6). 
