Napali # 1 well was drilled as dry hole and converted to a water disposal well UIC # 159422 on July 5, 2013. A 3" fiberglass water line was laid from the Napali #1 well head approximately 635' to the Napali #1 Tank Battery which contains 3-400 bbl water tanks. This is the only production equipment at the Napali # 1 well.
