Encana performed the following casing repair procedure on the above referenced well.

1. Retrievable bridge plug set at 6,700' (top perf at 6,792') and conduct pressure test – failed test
2. Plug and packer tests, leak isolated from 3,067' – 3,100'
3. Packer set @ 2,500' and pump 9 bbls 15.8# class G neat cement, displace and stage @ .5bbl increments. Allow 48hr cure
4. Drill out cement to 2,942' and pressure test – failed test
5. Pump 7.6 bbls 12.7# Fine Stem cement (balanced plug 2,606' – 3,157'). Allow 48hr cure
6. Drill out cement to 3,216' and pressure test – good test
7. Retrieve bridge plug and land tubing
