The last of the wells on this pad were completed in November of 2013. BBC is seeking an extension to August of 2015 to the interim reclaim deadline as BBC is currently constructing a compressor station (facility ID 434944) that requires us to access through this well pad location. The well pad would be reclaimed after the major construction efforts associated with the station. All stockpiled soils shall be protected from degradation and best management practices to prevent weed establishment and to maintain soil microbial activity shall be implemented.
