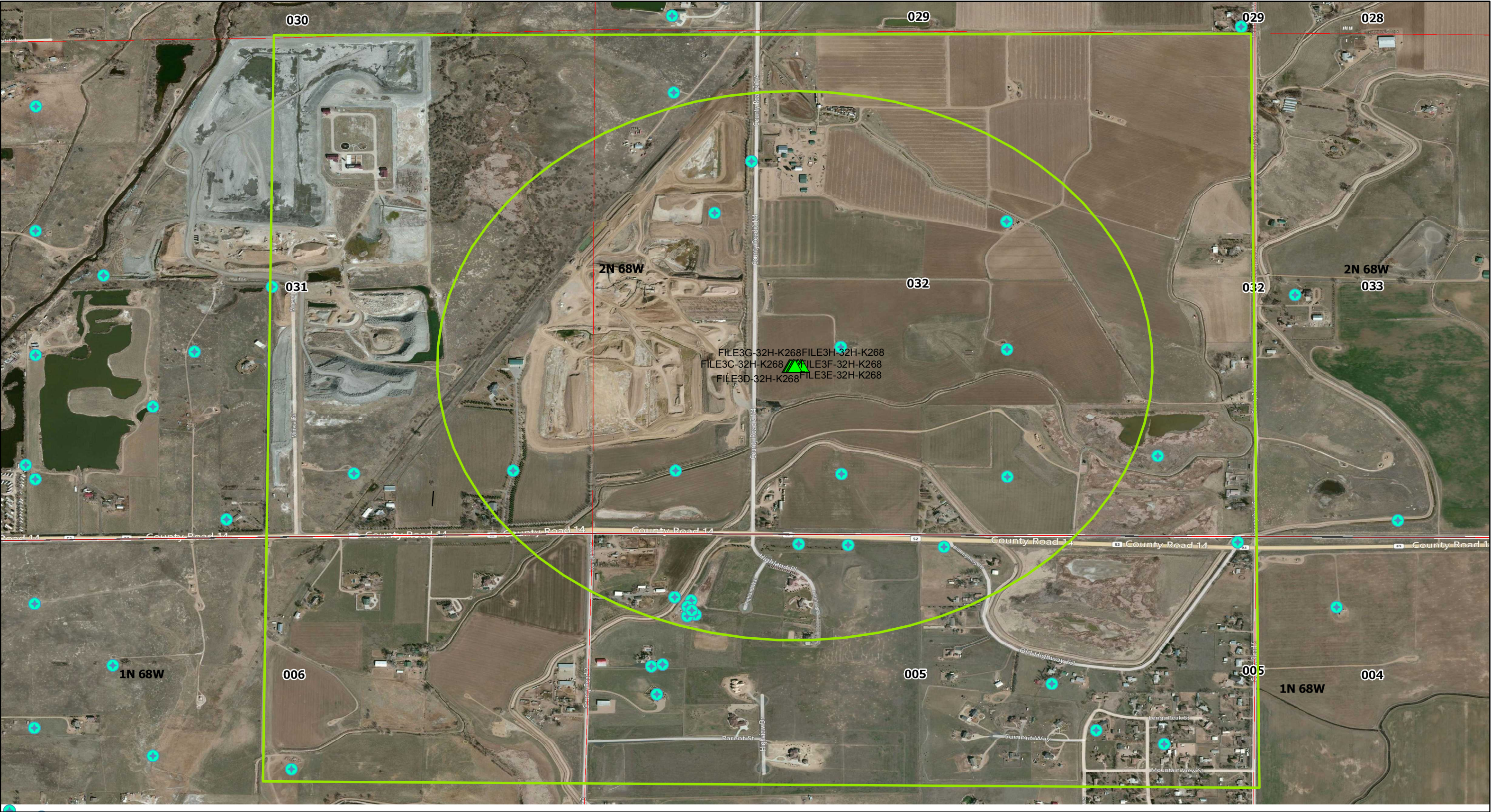


File Water Well Survey Map
