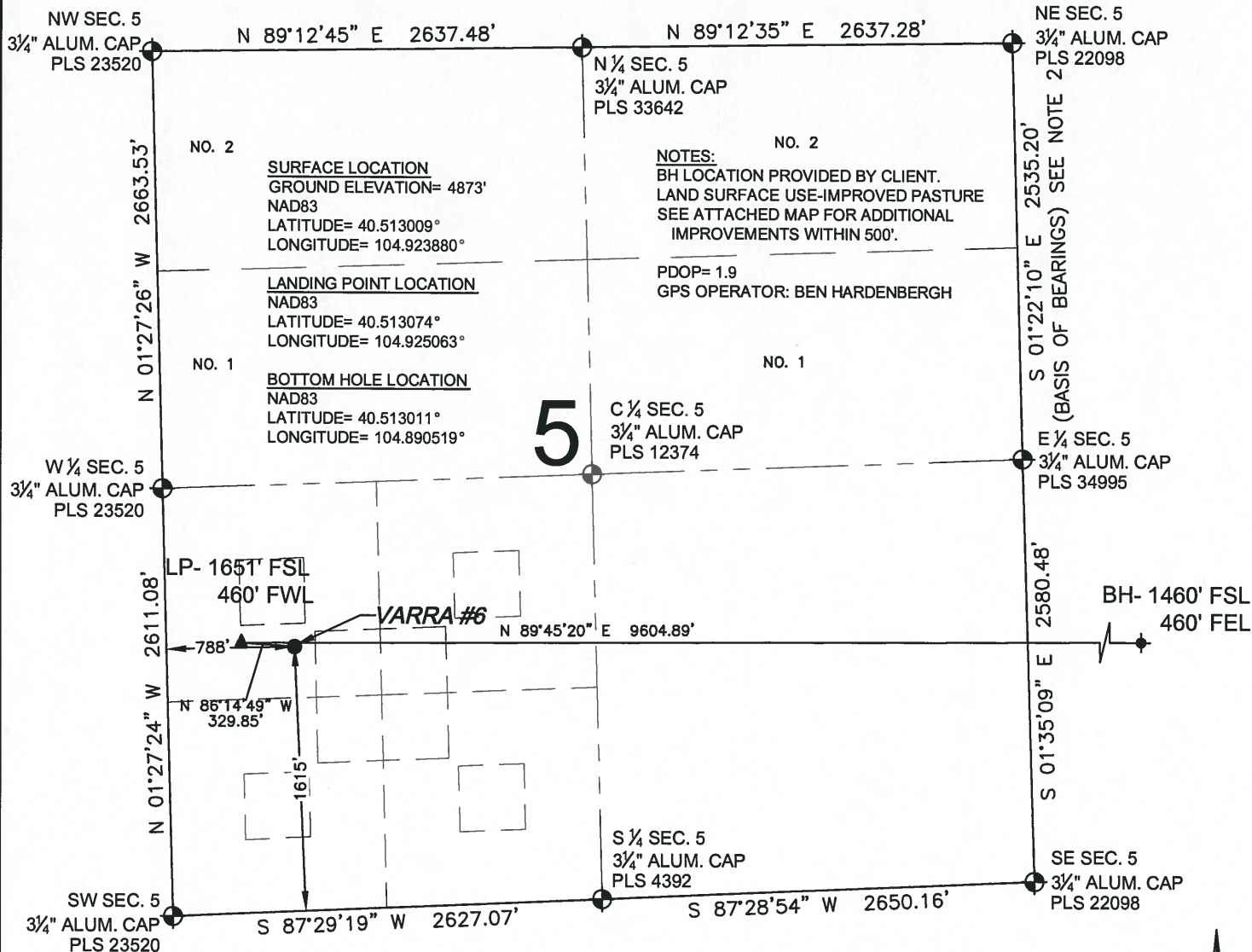


# WELL LOCATION CERTIFICATE: VARRA #6

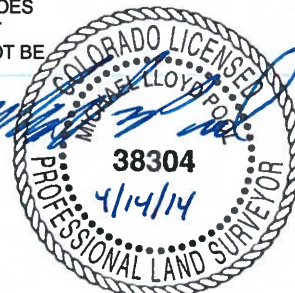
